The engine is countered balanced, lightened flywheel, high compression head, brass timing gear and V8 clutch.

Re-cored radiator with motometer cap.

The starter motor and generator were gone through, lubed and checked.

The head lights have the correct Ford blue print shaped reflector aluminized with the correct shaped filament in the bulb.

The carb has been rebuilt.

The brake drums and shoes matched to each other.

Transmission rebuild with new parts where needed as well as the tower with new forks and the ball is round giving positive location of gears.

Wiper motor rebuilt so it works as designed.

Trunk and car cover included.

The shocks are shot and the drivers side window needs help opening.

THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE GCRMARC, THEIR OFFICERS AND AGENTS ("Releasees") from all liability to the undersigned, his or her or their personal representatives, assigns, heirs, family members and next of kin ("Releasors") for any loss, damage, or claim therefor on account of injury to the person or property of the Releasors, whether caused by any negligent act or omission or other fault of the Releasees or otherwise while the undersigned or a family member is participating in any Event or using any of Releasees' facilities in connection with the Event.
- 2. ## Touring the Treasure & Space Coast in a Model A

Eighteen members and two guests from the Palm Beach A's embarked on a "Super Tour" during Florida's fabulous February. The three-day event, covered just under 400 miles, from Jupiter Lighthouse to Titusville and back. Six A's, two modern vehicles, and a motorhome participated. The goals of our trip were: 1. To provide a venue for fellowship between our club and



other collectors we met, 2. Take advantage of the educational opportunities on the trip and 3. Exercise those vehicles!




Day 1: Our first stop was at the Harbor Branch Discovery Center in Fort Pierce. A graduate student gave us a synopsis of the work currently being done in marine pharmacological research, dolphin tagging and studies, aquaculture, and water monitoring both in the intercostal waterway and the ocean. Next we headed to a great restaurant in Vero Beach but after being told there was a two hour wait we opted for fast food.

Stop number two was passing through part of The Jungle Trail, a dirt road in Vero Beach listed on the National Register of Historical Places that was built in about 1920 to haul citrus. We drove through vegetation hammocks along the Indian River before returning to a paved Route A1A. Just before the Sebastian Inlet we stopped at the McLarty Treasure Museum, the original site of survivors and salvagers from the Spanish Fleet of 1715 that sunk off the coast in a hurricane. The ships were

#### "A" VAST WAISTLINE

#### PART III — EVENING WEAR

Women's evening gowns are perhaps the most difficult to date in any era and the "A" era is no exception. The reason for this is quite simple: when buying, designing or sewing a gown, ladies did and do strive for that special, unlike any-other-gown. A one of a kind. It may be right in style (as Paris dictates) or she may have preferred touches of yesteryear or touches of her own design and genius, or a combination of all. The other apparel that may be harder yet to date is a wedding gown.

1927 — Gowns were long waisted in 1927 with the waist-line resting on the hipbone or just below. This line was emphasized in some manner by perhaps a wide sash, folded band or shirring. Bows, flounces or drapes were found at either center front or on the left side. Bodices were full, but straight-line, pulled in above the low waist to blouse over the snug hip area. For the fall season, there was a layered effect found in many gowns. Swathed belts and left sided effects by means of drapes, bows, sashes, flowers or

buckles still prevailed and were found drawn tight at the hip. At the close of the year, the waistline treatment on some gowns almost touched at the bottom of the natural waist. The straight bodices still bloused over the waist area with a tightness from the top of the hip down, 4-6", then fullness in the skirt below. Many gowns had sashes, bows or flounces at the left side with tails hanging lower than the skirt hem. Decorative jeweled buttons or buckles were also found on the left side.

1928 - The early part of 1928 found bodices even straighter and less bloused than past years. Snug hips were definitely the rule. Waistline was marked at the hipbone or just above. A variety of hip band treatments were found. Many bands started high in front, dipping lower in back or slanted upwards from one side to the other. Still others were found with lower hanging fronts or side draperies. Later in the year, sheath line gowns were found, though not tightly fitted. Some of these gowns were found with belts resting on top of the hipbone or many with bouffant side sashes, full gathered side drapes on left or right sides or with immense loops and bustles on the back of the gowns or with ruffles. This slender line gown with its attached flounces, drapes, etc., carried on through the end of the year. Straight line sheath top to hips or even the full length of the gown. Snug at the hips by means of shirring,

front wheels were doing what they were supposed to be doing. I think its

While we were working on my car, Paul came up with something that needed to be looked at on his Model A. So out come the jack and next someone was under his car.





It really makes a difference when you get so much help from your club members. As you can see in many of the next pictures, how everything



gets done faster and easier. The picture on the left shows Carlos putting on one of the front wheels while the picture below is Paul

putting one of the back wheels and you can also see Harold do something to one of the front Wheels.





With all the wheels on Harold went under the

left side back wheel with the wedge adjusting tool and turned the wedge while I checked to make sure we did not over tighten the brakes for the first step in adjusting until we did the other side so they would match.



In the picture on the right we are now under the other side of the car, hoping to match the other side. At this time checking the front wheels to make sure they are not tightening up at this time.

We moved to the next step in the adjusting board

and tighten up the backs one more time. Now it was time to make sure the




drapes or a fitted, but not tight, torso to on or below snug hips. A fullness was achieved in the skirt below in many cases by the addition of fabric such as overlapping panels or shaped flounces sewn on the sides or loops and bustles attached on the back of the gowns. A slender line was emphasized.

1929 - Early in 1929, the waistline was still found to be below the natural waist. The attached elaborate pieces such as drapes, flounces, etc., were not as predominant as in the past season. Fullness below the snug hips was achieved by gathered or tiered skirts, many in a basque effect. Spring saw many gowns with molded bodices, snug flat hiplines and almost normal, though not fitted, waists. Deep hip vokes and bustle ruffles were favored as were rather tubular, sheath like gowns which, though they fit the figure, were not tight. Narrow belts, most about 3/4" width, with jeweled buckles at center front were placed to indicate but not mark the natural waistline. At the close of the year, gowns were all with tight fitted hips and bodice was fitted but with a slight blousing over the almost natural waistline. The Princess and Basque line styles dominated. The silhouette in general was emphasized with tight-fitted hips and a higher to natural placement of the waistline.

It is this year that such a striking difference in the

fashion styles is noted. The early gowns of 1929 tend to lean toward the style and design of those in 1928 and earlier. From mid '29 to fall, some similar to '28 and others similar to 1930 will be found. The gowns of the latter part of '29 resemble more closely those of '30.

1929 gowns are extremely difficult to date as there were so many changes as well as holdovers available. In dating a '29 gown, one must take into account both the hem length and the waistline placement. The hemline just being uneven will not make it a '29. The uneven hem as previous articles have stated, began before and ended after the era. The same applies, as you've already read in Part I, to the below natural waistline placement. The extremely exaggerated high to low length of the gown (not those with attached sashes, flounces or drapes), but the gown itself is the best clue to a 1929, coupled with the waistline located somewhere above the hipbone, yet not exactly marking the natural waist. With a narrow belt, it will be placed so that the natural waist is indicated, though not tightly closed or pulled in. The top of the belt may just touch the natural waistline. The bodices are yet another clue. Though bloused, they were not as full as in 1928 or earlier - a tighter, closer-cut bodice, almost like the natural figure line, blousing gently over the slightly low waist. The hip area was more snug than in 1928, tight would be a better



On Saturday March 17th the Gold Coast Model A Club was invited to a BBQ. It was not with another Car Club. The invite


came from a Motorcycle Club

to the BBQ. This was not what I expected to happen. Most of the motorcycle club's only give us a thumb's up or a hand wave. While I was at it, I pulled the battery and floor boards ahead of time so that while I was under the car turning the adjusting yoke, I could have someone sitting in the car pushing on the clutch pedal to let me know when the pedal was right, without me climbing in and out from under the car. This way it would be easy to see what was going on with the pedal travel.

Now that 8 members of the club showed up, it was time to get to work. It was easy to take care of the clutch first. With that done Scotty Mac helped me put the inside together to a point where we could move on to the next step. It was time to dig out the brake adjusting board, for which I got the dimensions from the Model A Ford Mechanics Handbook by Les Andrews.





cheat sheets to make sure we do things right.

On the right Harold is putting on the lug nuts so we can get to the next step.







## Brake & Clutch Shop Tour/Audre & Dick

Saturday I had a shop tour to adjust or replace the brake's, along with doing same thing with the clutch. I knew it would take a while to do some of this, so I had Audrey's Son in Law Bob come over and give me a hand to put the car up on jack stands (I don't have a lift) and pull the brake drums off to see if we needed new brake linings, just in case I need them with many of the members of the club coming to give me a hand.

I now have a brain storm. Would it not be a good time to replace the fluid in the transmission, rear end and check the steer box. Also with the car up on jack stands, this would also be a good time to grease all the fittings.



These pictures show how easy it is when the car is off the ground. Picture on the left is only showing a couple on the front, there are more

there. Also don't forget those on the back.

The next pic shows that there is a grease fitting on the throw out bearing.

Make sure you get the grease fitting's on the break & clutch shaft. Because they are under the car, they often get missed.



The fitting on the left is on the bottom of the universal joint. This one also often gets missed.



The picture at the right is to let everyone know that there might be a cost to having a Shop Tour?




Members have knowledge of the motorcycles. I understand one of our Gold Coast members, Jerry Carbone, at one time owned a bike shop in Michigan.

Further Misadventures

of the Duerstocks

The first ten years of our marriage, Joe and I were the recipients of exceptional good fortune; something happened after our tenth anniversary in June, 1977.

Several weeks ago our 1973 LTD developed battery failure while I was at Cutler Ridge Shopping Mall. It was 12:30 p.m. and I figured there was plenty of time for AAA to find me, jump the battery and for me to get home to pick up Jason at school at 2:00 p.m. To make a long story short, the AAA dispatcher sent service to the wrong place; my grandmother locked herself out of our house and couldn't be reached to pick up Jason; Joe had left work for a doctor's appointment and then disappeared from sight; my neighbor, who usually comes to my rescue, was not at home, and with the pay phones now gobbling up quarters, I spent \$2.25 trying to get help for my car and Jason retrieved from school. I finally arrived home at 2:45 with Joe waiting for me, my grandmother at a neighbor's house and Jason on his way home with the rescuing neighbor. Our Penney's lifetime battery had died after only 13 months, so Joe had it replaced.

Two days later, Jason and I drove the LTD to the VACM meet at Hialeah Race Track in the pouring rain. We arrived home late that afternoon, drenched. Everything I decided to prepare for dinner required the loaf of bread I did not possess, so I decided to go out and get some. The new battery was also defective and now dead, Joe still had the wrecker in Hialeah and the stake truck was not running, so I borrowed a loaf of bread from a neighbor. The camel's back broke when my oven unit died in the middle of preparing dinner. I should have spent that week in bed.

Things went fairly well until the second week in November. The LTD's carburetor needed work so Joe arose early to take it to the local Ford dealer. I followed him there in the wrecker after taking Jason to school. Due to allergies, I must wear a gas mask when driving or riding in the Model A's so I only do so when absolutely necessary. On our way home in the wrecker, we heard 2 or 3 loud bangs, pieces started flying and we headed for the side of the road. Our right front tire lost  $\frac{1}{2}$  of its tread and we had no spare with us. (The wrecker only has 20,000 miles on it and apparently its original, brittle-with-age tires. Joe bought new ones on the way home from New Jersey, but hasn't put them on yet. He wants to restore the rims first.)

I called our rescuing neightbors and asked them to stand by while we attempted to limp the six miles home. Limp is an excellent way to describe our gait. Can you imagine going 10 m.p.h. up U.S. 1 in a rusty old wrecker with one tire bumping along, and the passenger wearing a gas mask? It's a wonder someone doesn't have us committed. By some stroke of good luck we made it home, but the ride was nauseating.


Many thanks to everyone who brought their Model A to the show, and all who showed up to support what we were doing.


