This age was a transitional period of time, not children, yet not quite adults. Their attire could be called the same, transitional, uniquely their own. Whether called teen, young adult, misses, young men or juniors, their style was not adult wear. Though some styles may bear a slight resemblance, it is only slight. It can not be stressed enough that these young prople should not be wearing Mom's more adult dress or gown or Dad's tuxedo or full evening suit. Junior attire was designed in a style which brought forth youth without being childish and a freshness that could not be matched by any adult wear.

#### GIRLS

Young ladies of this age began to dress for the time of day, function and occasion as they moved into a more adult world. Gone were playclothes as such, and in place came sportswear, both spectator and active styles. To this age also came the first formal attire which, for some, meant the allowable use of a little make-up to complete the ensemble. This was the age group in which one entered as an older child and left as a young adult.

Sleepwear: Choice consisted of a nightgown, or one or two piece pajamas. These were available in plain, striped, floral or print patterns, in an assortment of pastel shades or white. The fabrics included nainsook, cotton, rayon, flannelette, cotton pongee, madras, crepe de Chine (especially the crinkly type) as well as wool blends for winter. For sixteen and older, there were pajama sets with matching jackets, in rayon as well as other fabrics.

General wear: For schoolwear, a one piece dress in a simple tailored line of lightweight wool, plain silk or cottons such as gingham, pique, voile or broadcloth was worn. Skirts and blouses or jumpers and blouses were other popular choices in fabrics of jersey or velveteen for winter or cotton or linen for warm weather. For street or shopping, a tailored suit was most appropriate or a simple tailored dress. Street ensembles were subdued in color and of simple cut, devoid of any fussy trimmings. The fabric was dependent upon the season. Afternoon dresses were a change from the younger version of dress-

Karen Christensen was chairperson for this show, Mike Vitetta's Tech-Tip




Fig. 18A. Wiring diagram showing the internal circuits of the model A Ford cars not equipped with cowl lamps, with two bulbs in each headlamp.

generator is the source of electrical current supply and also charges the battery. See Dyke's Automobile Encycloprdia, pages 332, When starting to trace one of the several electrical circuits, begin with the positive (+) terminal of the battery or generator. The battery is the source of supply when the engine is not running, or generator is running very slowly. When the generator speed is increased to the point where its voltage becomes greater than the battery voltage, the relay points close and then the 448 and 427 explaining the principle of operation of the current cut-out (relay), how to trace circuits, etc.
