Men's attire varied according to age, occupation and function. Suits, for example, could be a conservative style for the older, over-forty gentleman and a collegiate style for the younger man. As usual with rules of fashion, exceptions were found. A conservative style might also have been worn by a younger man depending upon occupation or preference.

For occupations, there were work suits of a durable washable material worn, for example, by a farmer or a mechanic. The coat was worn to town, then removed when back to work in the field or garage.

Specific functions included suits designed for hunting, camping or other sporting events; formal wear being another specific function. What type of formal wear worn was dependent on not only the time of day, but also the time of year.

Suits consisted usually of three pieces. The coat was referred to as a coat not jacket, whether for business, work, casual, formal or sports. The term jacket as well as sports jacket referred to other kinds of clothing. A standard style vest was single breasted, five buttons, finished with four welted pockets. Trousers was the term most often used, occasionally trouser pants, to denote work clothes that did not have permanently attached suspenders such as overalls might have had. Slacks was a term used for light-weight summer trousers. Trousers for dress or casual suits may have been all or half lined.

When referring to shoes, this term may denote either "high top" style or the low cut oxford style. Both were appropriate to daytime business or general wear.

Rather than put the attire into separate areas as past articles, this article will list the types of attire and some of what was needed to make it a complete ensemble.

MARC OF FASHION **Ensemble Specifics - Men Part 1**

Two-piece pajamas had long sleeves with button fronts in coat style or slip-over-the-head tops. These had soft shirt or military stand-up collars or were collarless middy neck styles. The bottoms had drawstrings or draw tapes in the waist or knitted elastic waistbands. Warm weather fabrics included cotton broadcloth or percale and in cool weather flannel was popular. They were solid colors or assorted stripes and the predominate colors included white, tan, blue or lavendar. Onepiece pajamas were available, with the look of two-piece; the pants were sewn to the coat and had a dropped seat.

Nightshirts were long sleeved, pull-over-the-head or buttoned yoke styles. They were collarless, or had military standup or regular turn down collars. For warm weather muslin was the popular choice and in cooler weather muslin or flannelette was used in white or assorted stripes.


Other apparel for sleepwear is basically optional. Robes were all a long length with shawl collars, two lower patch pockets, and a wrap-around style which was held closed with a braided girdle (rope). Blanket cloth or flannel were the most popular fabics in fancy designs. Shades that were favored were blues, wines, grays, tans and browns. Slippers in the slip on style were most predominate and often matched the robe's predominate color. Materials included felt or soft leathers in black, tan or brown. It was not unheard of for men to wear an all-in-one short or long length union suit under a nightshirt in cool weather. Socks may be worn, though not necessary with the slippers.

Lounging pajamas were available in all silk or silk blends as well as rayon. Robes were designed in style as ordinary wear but were of richer materials such as silk or satin. These were often in a fancy pattern with lapels, cuffs and trim in a solid color. Slippers were often made of soft leather with black patent leather favored.

The more elegant lounge or dressing robes, all pajamas and nightshirts and some of the ordinary robes had a breast pocket.

A handkerchief used for ordinary sleepwear was of white cotton or linen. A handkerchief for the breast pocket of a dressing gown may be of silk or silk blend in color harmony. or contrast to the robe.

General Wear choice. Fur or wool felt was the most often used material in Business suits consisted of a single or double breasted coat, brown, black, gray or tan. May 15 through labor day were trousers and most had a matching (in material) five button the dates for wearing a straw hat. Popular straw vest. The latter was a popular choice of cool weather). General wear socks were usually seamless with the conservative man, especially in navy blue or black. Ties ribbed tops, reinforced heel and toe. Garters were optional, were bow, Windsor or four-in-hand made of silk, silk blend usually worn after the sock cuff lost its elasticity. or rayon. Tie color was also coordinated to the suit color. For undergarments, the all-in-one type was favored. Do You Remember ?



Carol Lawatsch's " Getting To Know You" SCOTT MCELROY

Scotty Mac, as he calls himself, has a unique perspective on the 50 year history of Gold Coast MARC. His parents were founding members when the club charter was signed in 1966. Scott was 16 years old, and had already helped his dad, Denton McElroy, restore a 1930 Model A Coupe they found in a junk yard. Scott says "My 16th birthday was on a Wednesday, I got my driver's license on Thursday and drove the Model A to school on Friday".

The McElroy family, Denton, Lee, 7yr old Scott, foster sister, Ellen, and Jet, the family dog arrived in Florida in1957. They came from Springfield, PA. & settled in Pompano Beach where Scott attended school. Scott's main activity during Jr. & Sr. High School was the tennis team where he held the ranking of number #3 player. After graduating in 1968, Scott went on to University of South Florida in Tampa where he majored in Management Science. It was in an era of early computers and Scott wrote computer programs in Fortran and Cobal. When he graduated in 1972, his father announced, to Scott's surprise, that Scott would then take over full time responsibility in the family business. Dent had the foresight to see that auto air conditioning would be the next big thing, so he bought Frigmobile, an automotive air conditioning service & repair business in 1959.

Dent completed a two story, 5 car garage in 1971 and made 50% of the top floor available for Gold Coast MARC. That space became the famous "Club House", GCMARC's home from 1972 to 2007 when Scott closed Frigmobile after 48 years of operation. Over time, Scott bought the business name and stock. He was manager, VP, then President until his retirement in 2007. Scott recalls his mother arriving early in "The Club House" on meeting nights to tidy up and make the coffee. Dent was Sargent at Arms and on the Board of Directors. Scott participated in GCMARC events, shows and activities, as well. Some folks who were around for the club house years are still members today.

There is an impressive list of vehicles owned over the years by the McElroys- a 1913 Hupmobile, a 1948 Playboy, a 1947 Willys Knight/and a 1948 Indian Chief, to name a few. Vehicles currently owned include 1931 Model A Sport Coupe, a 1931 Model A Roadster, a 1956 "T" Bird, a 1956 Chevy Pickup Truck, and a 1972 Harley Sportster motorcycle, which Scott still rides. When I asked Scott to tell us something we don't know about himself, he said " I earned a black belt in Karate in my thirties, and I sing in the choir at the Zion Lutheran Church". (The same church his parents started in 1958). Scott and Shanon, his partner since 1992, live in the same house in which he was raised. They spend time in a wonderful family owned log cabin in Black Mountain, NC. Scott enjoys visits with his children in Colorado, son Ryan, and daughter Jennifer and her 2 sons, Jaxon, not yet one year old, and Braedon age 4.

From Clark Ballard Congratulations on 50 Years of MARC

First let me say that the Gold Coast Region Model A Restorers Club is the best car club I've ever been a part of. From the very first meeting I attended in 1988 until today the members have been friendly and supportive and fun to be with. It didn't matter who you were, how much money you had, what condition your car was in, or what you looked like, everyone was accepted and included. Not many organizations can say that. And of course, the Model A's that we all

love were the glue that held everything together.

Dick asked that I recount some of my favorite memories about the club and that's a difficult assignment since there were so many. But the overnight trips we took up to the Pirate's Cove Resort in Stuart were always great. We'd leave in the morning, stop at a small park on A1A for a picnic lunch and arrive at Pirate's Cove in the early afternoon.

Whoever was hosting the trip would have one room set up as a hospitality suite with snacks and beverages, etc where we would gather. Then everybody would go jump in the pool and hang out for a couple of hours talking about Model A's and other things of interest. Then we'd all meet for dinner, then probably back to the hospitality room for a while before retiring for the night. Next morning everybody would wander in for breakfast on random schedules and then by mid-morning we'd head for home.

For some reason, some rather unusual and questionable things seemed to take place on these trips, which provided spirited conversation and detailed examination by our members for weeks, and even years to follow. 



Mike Vitetta's Tech-Tips

Using the ammeter for troubleshooting

How many of you actually look at your ammeter? Did you know that it can assist in troubleshooting your car when it won't start? If your A is wired as it was in 1930 and beyond and has a point ignition system as opposed to an electronic ignition, the ammeter can be of great help.

Before you start the car and turn on the key the ammeter should be at zero. Turn on the key and hit the starter without depressing the brake. The ammeter should "wiggle" a little discharge, a little zero and so on. This is because the points are usually closed and therefore you see the current draw of the ignition circuit as the points open and close. If the meter "wiggles" an the car won't start you have a fuel problem. No wiggle, electrical problem.

When you turn off the car, glance at the meter to see it is at zero before you exit the car. If not, you have a problem, most likely the brake light switch is stuck on. If you don't fix it your battery will be drained.

Gas Cap Fix

Reproduction gas caps have a quality issue that can cause you some amount of grief. A large single rivet in the center on the bottom of the cap holds the assembly together. The rivet goes through the bottom metal grabbing devise, a red colored gasket, and a large brass flat washer. Off to the side is drilled a vent hole through all three parts. Without a vent hole the tank would experience a vacuum lock as the gas in the tank is depleted. Eventually it would stop the gravity flow of gas to the carburetor and the car would appear to run out of gas. It is possible and extremely likely, that as the cap is twisted on and off the tank numerous times, one or more of the three parts will rotate out of position on the center rivet. When this happens the vent hole will be blocked off and the vacuum thing will happen. When you remove the cap you are liable to hear a " Whoosh" sound as air rushes into the tank to equalize the vacuum.

Before you allow the vent hole to become blocked it is a good idea to modify the cap. Drill a second hole through the three pieces. Be careful not to drill clear through the top of the cap, just the three pieces. Tap the hole for a 6-32 screw. Lock-tight or epoxy it in place so it won't fall out into the gas tank. The screw will prevent the three parts from rotating out of position and the vent hole will maintain alignment through the three separate parts.

Complete Lube Job?

You did a COMPLETE lube job? You oiled the linkages and distributor, applied grease in all the, what, 22 fittings, Good for you!

How about the starter crank hole? It needs a few squirts of oil every 500 miles, says Henry. There is a small hole inside the crank hole. It is hard to see. The oil leaks down to the front spring. The hole may need to be cleaned out with a piece of wire before oiling. I bet you didn't know that!
