Executive Summary

SLR Consulting Limited was commissioned by Obsidian Developments Limited to prepare an Historic Environment Desk-Based Assessment to inform a proposed residential development upon land at Heol Lluest y Bryn, Carmarthen, SA31 1GZ. This report assesses the evolution of the historic environment both within the Site and its wider surroundings and identifies known and potential historic assets within the Site, and beyond its boundary, which may potentially be affected by the development proposals. Both physical and non-physical (i.e., as a result of change to setting) effects upon the significance of those historic assets are then assessed.

The report has determined that the proposed development will have no physical impact upon any designated historic assets. Based on an assessment of the Site's topographical and geological profile, baseline data, historical mapping, other documentary research, and a consideration of past impacts within the Site area, the report has also concluded a limited potential for significant archaeological remains of all dates. Neither will the proposals result in any harm to the significance of any historic assets as a result of change to setting, including the North Carmarthen Conservation Area. Heneb: Dyfed Archaeology recommended that the 2017 outline planning application (reference no.: W/35903) was subject to an archaeological condition. Such archaeological investigation may comprise an initial geophysical survey, any the requirement for additional archaeological investigations (such as trial trenching) would be dependent on the results of said geophysical survey.

Dywedodd yr adroddiad na fydd gan y datblygiad arfaethedig unrhyw effaith gorfforol ar unrhyw asedau hanesyddol dynodedig. Yn seiliedig ar asesiad o broffil tirlunio a daearegol y Safle, data sylfaenol, mapio hanesyddol, ymchwil ddogfennol eraill, ac ystyriaeth o effeithiau gorffennol o fewn ardal y Safle, daeth yr adroddiad i'r casgliad bod potensial cyfyngedig i adfeilion archaeolegol sylweddol o bob dyddiad. Ni fydd y cynigion hefyd yn arwain at unrhyw niwed i arwyddocâd unrhyw asedau hanesyddol o ganlyniad i newid i osodiad, gan gynnwys Ardal Gadw Caerfyrddin Gogledd. Argymhellodd Heneb: Archaeoleg Dyfed y dylid rhoi amod archaeolegol ar geisiadau cynllunio amlinellol 2017 (cyfeirnod: W/35903). Gallai'r ymchwiliad archaeolegol gynnwys arolwg geomagnetig cychwynnol, ac mae'r angen am ymchwil archaeolegol ychwanegol (fel trochi prawf) yn dibynnu ar ganlyniadau'r arolwg geomagnetig hwnnw.

1.0 Introduction

In April 2024, SLR Consulting Limited was commissioned by Obsidian Developments Limited (hereafter 'the Client') to prepare an Historic Environment Desk-Based Assessment (HEDBA) to inform a proposed scheme of residential development on land at Heol Lluest y Bryn, Carmarthen, SA31 1GZ (NGR: SN 41463 21005) (**Figure 1**; henceforth 'the Site').

1.1 Proposed Development & Planning Background

The Client submitted pre-application advice to Carmarthenshire County Council (CCC) on 29th January 2024 (reference no.: PRE/02018). The proposed development comprises a residential development of 34 residential units, together with access, landscaping, and associated works. The pre-application response from CCC stated that:

The proposed development is in close proximity to the North Carmarthen Conservation Area and has the potential to have a detrimental impact on its setting if not considered and designed appropriately. A Heritage Impact Assessment would be beneficial in support of any application. It is also noted that in general the proposed site has what appears to be a historic path running through its centre with traditional wrought iron swing gates leading onto Springfield Road. It is advised that it would be considered appropriate to conserve this feature as part of any development proposed.

An outline planning application (reference no.: W/35903) for a residential development within the Site was granted in June 2017. Dyfed Archaeological Trust (DAT) (now Heneb: Dyfed Archaeology) provided advice to CCC and recommended that an archaeological condition should be placed on the planning consent:

No development shall take place until a qualified and competent archaeologist has submitted a written scheme of investigation (WSI) for approval in writing by the local planning authority. This WSI will describe the different stages of the work and demonstrate that it has been fully resourced and given adequate time. On behalf of the local planning authority, their archaeological advisors (DAT DM) will monitor all aspects of this work through to the final discharge of the condition. This work will not be deemed complete until all aspects of the WSI have been addressed and the final report submitted and approved.

Reason: to protect historic environment interests whilst enabling development.

1.2 Scope of Report

This report presents the results of a HEDBA prepared in respect to historic assets of an archaeological and built heritage nature. It identifies known and anticipated historic assets within the Site, and its vicinity, and provides a level of assessment sufficient to allow a full understanding of the impact of the proposals upon the significance of known or potential historic assets, in accordance with the Planning Policy Wales (PPW) (2024), Paragraph 6.1.26 and Technical Advice Note (TAN) 24 (2017), Paragraphs 4.7 and 4.8. The potential effects of development are discussed in accordance with terminology of PPW and TAN 24.

This HEDBA has guided by a Written Scheme of Investigation (WSI) which was submitted to Mike Ings, Archaeological Planning Manager, Heneb: Dyfed Archaeology for review, comment, and approval prior to the assessment being undertaken. The WSI was approved by Heneb in April 2024 and is included as **Appendix D** of this report.

1.3 Standards

The assessment has been undertaken in accordance with all relevant statute, policy, and guidance, including PPW (2021), TAN 24 (2017), the Chartered Institute for Archaeology (ClfA) Standard and guidance for historic environment desk-based assessment (2020), Cadw's Conservation Principles for the Sustainable Management of the Historic Environment in Wales (2011), and Setting of Historic Assets in Wales (2017).

The assessment has been undertaken, and the report prepared, by James Evans, ACIfA, Senior Archaeology and Heritage Consultant, SLR Consulting Limited. The report has been reviewed, and the



project managed, by Dr Emma Wells, MCIfA, FSA, Technical Director – Archaeology and Heritage, SLR Consulting Limited.

2.0 Methodology

2.1 Data Procurement

2.1.1 Study Area

For the purposes of baseline data collection, a 1km study area was utilised for archaeological remains. Whereas, for built historic assets, all assets deemed to be potentially susceptible in the wider landscape of the Site were considered.

2.1.2 Sources

The following sources have been consulted:

- Cof Cymru Cadw website, for depictions and associated record descriptions of designated historic assets in Wales;
- the Heneb The Trust for Welsh Archaeology: Dyfed Region Historic Environment Record (HER), for sites and events data;
- the National Monuments Record Wales (NMRW), held by the Royal Commission on the Ancient and Historical Monuments of Wales (RCAHMW), for any additional archival data about sites, buildings and monuments, accessed via the Historic Wales website;
- the Data Map Wales website's library of open access LiDAR data (DSM and DTM);
- the Ordnance Survey open-source library, for topographic and cartographic data, including elevation point cloud, contour and hydrological data;
- historic cartographic sources, including large-scale county surveys, tithe mapping and early Ordnance Survey editions;
- the Welsh Government Aerial Photographs Officer for available aerial photographs;
- other online resources, including: the British Geological Survey; the Cranfield University Soilscapes viewer; and the National Library of Scotland's online mapping database;
- the Carmarthenshire County Council (CCC) online planning application portal, for relevant documentation submitted in relation to proximate applications;
- Carmarthenshire Archives online catalogue for any relevant material; and
- grey literature relating to excavations within, and within proximity to, the Site.

2.1.3 HER & NMRW Data

A proportionate level of HER and NMRW data, sufficient to inform the assessment of archaeological potential, significance and potential impact presented in this report, was obtained. The HER and RCAHMW data were reconciled and analysed within the context of the objectives of the present assessment.

While all the HER and NMRW data received has been reviewed and considered (all data is included in **Appendix A** and illustrated in accompanying figures), not all records (sites and events) are discussed further within this report, only those that are of relevance to the determination of potential, significance, and potential impact.

The HER and NMRW data contained many duplicate asset entries, largely for Listed Buildings and Scheduled Monuments. These have been referenced using their Cadw reference number rather than their HER and / or NMRW number within this report.

2.1.4 Archives

Carmarthenshire Archives were visited in April 2024 to view relevant historic mapping and documents associated with the Site. Discussions with the Archives Assistant revealed that the area immediately



north of the Carmarthen town, i.e., the Site, was not within the landholdings of any estates. As such, the Site was not included in any early detailed mapping, i.e., estate maps.

Nonetheless, late 18th century and early 19th century maps were viewed at the archives, including Carmarthen Town (1786) (archives reference no.: GB 211 PD5C/221) and Plan of Carmarthen (1834) (archives reference no.: GB 211 CDX319). Although these only recorded detail of the town centre of Carmarthen maps and did not show the Site.

2.1.5 LiDAR Data

The most recent LiDAR data of Wales, i.e., that data captured in 2020 – 2022, does not cover the Site.¹ The most recent data to cover the extent of the Site dates to 2009, and the best available data from this date comprised 1m digital terrain model (DTM) and digital surface model (DSM).

The data was acquired in ASCII raster format and was processed for better visual representations of the topography in both ArcMap 10.5.1 and Relief Visualization Toolbox (RVT) 2.2.1 (2019).

The output images from the RVT software were then imported into ArcMap 10.5.1 where further settings manipulation was undertaken to enhance the visualisation for archaeological feature detection. The best visualisation comprised using a Principal Component Analysis (PCA) visualisation, and this data formed the basis within the desk-based assessment and is illustrated on **Plate 2** and **Plate 8**.

2.1.6 Site Inspection

A Site inspection was undertaken in April 2024 to assess the Site within its wider landscape context, identify any evidence for previous disturbance, and examine any known or suspected archaeological features. Photographs can be seen in **Appendix C** of this report (**Photos 1** – **19**).

2.2 Assessment of Significance

Historic assets have been assessed in terms of their significance, following the requirement in Technical Advice Note 24: The Historic Environment (TAN 24) (2017), and taking account of Cadw's guidance on Conservation Principles for the Sustainable Management of the Historic Environment in Wales (2011) (hereafter referred to as 'Conservation Principles'). Significance, within the historic environment, is defined by Cadw simply as 'The sum of the cultural historic values of a place'.

Conservation Principles (2011) and the TAN 24 glossary provide that an asset's significance derives from its historic 'values', which are defined by the latter as follows:

- **Evidential Value:** value deriving from the potential of a place to yield evidence about past human activity;
- **Historical Value:** value deriving from the ways in which past people, events, and aspects of life can be connected through a place to the present;
- Aesthetic Value: value deriving from ways in which people draw sensory and intellectual stimulation from a place; and
- **Communal Value:** value deriving from the meaning of a place for the people who relate to it, or from whom it figures in their collective experience or memory.

This approach allows for a detailed and justifiable determination of heritage significance and the values from which that significance derives. Neither policy, however, provides a classification system for historic assets to determine their 'level' of significance. It is generally considered that designated historic assets, such as Scheduled Monuments and Listed Buildings, are of greater heritage significance that non-designated or unrecorded historic assets. Within this assessment, any hierarchy of significance within these categories has been determined by evaluating the available evidence and exercising professional judgement.

The significance of known and potential historic assets identified within the Site boundary is described where relevant in this report. In respect of identifying the importance of setting to the identified

significance of a historic asset, Cadw's Setting of Historic Assets in Wales (2017) will be utilised; specifically, the staged approach, as follows:

- **Stage 1:** identify the historic assets that might be affected by a proposed change or development;
- Stage 2: define and analyse the settings to understand how they contribute to the significance of the historic assets and, in particular, the ways in which the assets are understood, appreciated, and experienced;
- Stage 3: evaluate the potential impact of a proposed change or development on that significance; and
- Stage 4 (if necessary): consider options to mitigate or improve the potential impact of a proposed change or development on that significance.

2.3 Assessment of Impact

Welsh national policy does not specify how the degree of harm to historic assets (impact) should be articulated. *Conservation Principles* (2011) however provides the following guidance:

Every reasonable effort should be made to eliminate or minimize adverse impacts on historic assets. Ultimately, however, it may be necessary to balance the benefit of the proposed change against the harm to the asset. If so, the weight given to heritage values should be proportionate to the importance of the assets and the impact of the change upon them. (Cadw 2011, 15).

Paragraphs 6.1.25 of PPW (2024) also provide the following in relation to harm to non-designated historic assets specifically:

In cases involving less significant (than designated) archaeological remains, planning authorities will need to weigh the relative importance of the archaeological remains and their settings against other factors, including the need for the proposed development. (Welsh Government 2021, 129).

The above is interpreted as weighing the significance of the historic assets in the balance with the impact of the change or 'harm'. The level of harm is determined within this assessment by applying professional judgement.

As clarified in the High Court, preservation does not mean no change; it specifically means no harm.² This is echoed in *Conservation Principles*, which states:

Change to historic assets is inevitable... to ensure the long-term future of historic assets changes need to be managed to ensure that their significance is not diminished as a consequence. (Cadw 2011, 18).

The assessment of anticipated development effects can thus be seen to have been undertaken in accordance with a robust methodology, formulated within the context of current best practice, the relevant policy provisions, and key professional guidance.

3.0 Statute, Policy, & Guidance

3.1 Statute

Scheduled Monuments are protected from physical development effects under the **Ancient Monuments and Archaeological Areas Act (1979)**.

Conservation Areas may be of archaeological interest and are protected under Section 72(1) of the **Planning (Listed Building and Conservation Areas) Act (1990)**; this provides that 'special attention shall be paid to the desirability of preserving or enhancing the character of that area'.

Registered Parks and Gardens, Registered Battlefields and World Heritage Sites do not have any statutory protection in and of themselves, though all are afforded a high level of protection under national planning policy.

The **Historic Environment (Wales) Act (2016)** was introduced to give more effective protection to Listed Buildings and Scheduled Monuments, enhance existing mechanisms for the sustainable management of the historic environment, and introduce greater transparency and accountability into decisions taken on the historic environment. It also introduced several stand-alone provisions for Wales, e.g., the compilation and maintenance of a list of historic place names in Wales, HER for each local authority area in Wales, and the establishment of a panel of persons, to be known as the Advisory Panel for the Welsh Historic Environment.

In June 2023, the **Historic Environment (Wales) Act 2023** received Royal Assent. The new Act brings the principal legislation for the historic environment together in one place, states it explicitly for Wales without confusing references to other jurisdictions and provides the law and its supporting documentation in fully bilingual form. However, the Act will not be brought into force until the latter part of 2024.

3.2 Policy

3.2.1 Planning Policy Wales (Edition 12, 2024)

Applicable national policy comprises of Planning Policy Wales (PPW) (2024), and specifically the following paragraphs:

Paragraph 6.1.9, which states that:

Any decisions made through the planning system must fully consider the impact on the historic environment and on the significance and historic values of individual historic assets and their contribution to the character of place.

Paragraph 6.1.24, which relates to highly significant archaeological remains, state that:

Where nationally important archaeological remains and their settings are likely to be affected by proposed development, there should be a presumption in favour of their physical protection in situ. It will only be in exceptional circumstances that planning permission will be granted if development would result in an adverse impact on a scheduled monument (or an archaeological site shown to be of national importance) or has a demonstrably and unacceptably damaging effect upon its setting.

Paragraph 6.1.25 and Paragraph 6.1.26, which relate to non-designated historic assets, state that:

In cases involving less significant archaeological remains, planning authorities will need to weigh the relative importance of the archaeological remains and their settings against other factors, including the need for the proposed development.

Where archaeological remains are known to exist or there is a potential for them to survive, an application should be accompanied by sufficient information, through desk-based assessment and/or field evaluation, to allow a full understanding of the impact of the proposal on the significance of the remains. The needs of archaeology and development may be reconciled, and potential conflict very much reduced, through early discussion and assessment.



3.2.2 Local Planning Policy

Local planning policy is provided in the Carmarthenshire Local Development Plan, 2006 – 2021 (adopted December 2014). A revised Local Development Plan (LDP), covering the years of 2018 – 2033, is yet to be deposited / adopted. As such, the existing 2006 – 2021 LDP will remain in place for all planning decisions, in line with advice issued by the Welsh Government.

Policy relating to the historic environment is included in Policy EQ1 of the LDP and is quoted below.

Policy EQ1: Protection of Buildings, Landscapes and Features of Historic Importance

Proposals for development affecting landscapes, townscapes buildings and sites or features of historic or archaeological interest which by virtue of their historic importance, character, or significance within a group of features make an important contribution to the local character and the interests of the area will only be permitted where it preserves or enhances the built and historic environment.

3.3 Guidance

3.3.1 Technical Advice Note 24: The Historic Environment (2017)

TAN 24 is a key policy document providing detailed guidance on how the planning system considers the historic environment during development plan preparation and decision making on planning applications. TAN 24 is to be read in conjunction with PPW.

3.3.2 Cadw Best Practice Guidance

Cadw has produced several best-practice guidance documents that complement the legislative framework and associated planning policy and advice and support the sustainable management of the Welsh historic environment. Some of these have been discussed above and will be used in this assessment.



4.0 Archaeological Baseline

This section sets out the archaeological baseline relative to the Site and its immediate surroundings, in order to identify known historic assets and to inform an understanding of the Site's broader archaeological potential.

4.1 Designated Historic Assets

There are no designated historic assets within the Site.

Immediately to the west of the Site is North Carmarthen Conservation Area (**Figure 2**). There are also several designated historic assets located within the study area, including further Conservation Areas, a Registered Historic Landscape, Scheduled Monuments, and Listed Buildings (**Figure 2 – 4**). These assets are discussed in more detail in Section 6.

4.2 Geology & Topography

The Site is located on hillslopes *c*. 750m north of Carmarthen town centre and *c*. 770m north-west of the River Tywi. The Site is predominantly surrounded by residential properties: to the north and west by Springfield Road, to the east by Llwynmeredydd and Parc Yr Onen, and to the south by Heol Lluest-Yr-Bryn. The elevations within the Site vary from *c*. 65m above Ordnance Datum (aOD) at the southern boundary with Heol Lluest-Yr-Bryn to *c*. 83m aOD at the northern boundary with Springfield Road.

The underlying geology of the Site comprises mudstone belonging to the Abergwilli Formation. There are no superficial deposits recorded within the Site by the British Geological Survey (BGS).³ The soils within the Site are freely draining, acidic and loamy which overlie the bedrock. The land is mostly steeply sloping, with restricted mechanised access, and would only be suited to grassland and / or rough grazing.⁴

4.3 Previous Archaeological Fieldwork

No previous archaeological investigations have taken place within the Site boundary.

There have been several archaeological investigations undertaken in the study area, including field evaluations, excavations, and watching briefs. These investigations are listed in **Appendix B**. Artefacts and features pertaining to these investigations are discussed, where relevant, below.

4.4 Prehistoric (pre-74 CE)

No prehistoric features / artefacts have been recorded within the Site.

Nonetheless, there is a henge-type earthwork (**Figure 5**, **226**) located *c*. 340m north of the Site. During the Late Neolithic period in Wales there was a development of regional ceramic styles, a decay of megalithic tomb building traditions and a spread in the practice of cremation and 'henge' monuments (Savory 1980, 208). The henge-type earthwork recorded in the HER is circular, measuring *c*. 75m in diameter, with a measuring *c*. 1m in height and *c*. 4m in width. However, the earthwork is located within an area of thick and dense vegetation and has not been the subject of detailed archaeological investigation to determine its origin.

In the Neolithic period, burial monuments consisted of communal burials in the form of chambered tombs and earthen long barrows; however, in the Late Neolithic period and Bronze Age (c. 2,500 BCE – 800 BCE) there was a shift from communal burials to more 'individual' burials (Lynch 1980, 237 – 239). These individual burial monuments predominantly comprise barrows, sometimes with a surrounding ditch and occasionally an outer bank, known as ring barrows.

A possible ring barrow (**Figure 5**, **224** & **413087**) is located *c*. 250m north of the Site, which consisted of a ring-shaped feature of small stones and earth. The bank spread to a width of 5m with a hollow central area, and an overall diameter measuring *c*. 22m. The feature is also clearly visible in early

historic aerial photography (**Plate 1**). However, a site visit by DAT in 2000 noted that the feature was significantly denuded and barely visible, possibly related to modern agricultural activity. Additionally, the RCAHMW has considered that the feature may be a post-medieval in date and associated with nearby ridge and furrow cultivation.



A further possible ring barrow (**Figure 5**, **227**) is recorded *c*. 450m north of the Site. DAT visited the site in 1985 but the feature had no visible presence on the ground, and it was noted that it was located within an arable field regularly ploughed. Therefore, it was presumed that the feature had been destroyed by modern agricultural activity. The feature was not visible in the aerial photography viewed for this assessment.

There are cropmarks (**Figure 5**, **14300**), located *c*. 460m west of the Site, which appear to represent a circular structure and an adjoining enclosure on the hillslope above Penlan. It is thought that the cropmarks could represent Iron Age (*c*. 800 BCE – 74 CE) activity. Evidence of Iron Age timber roundhouses, two / four-post structures and storage pits are known to present as cropmarks and soil marks. Well preserved examples have been recorded in north-west and south-west Wales, but examples in south-west Wales have been largely erased by continuous agriculture and land use (Ritchie 2018). The cropmarks are difficult to identify in the historic aerial photography and modern satellite imagery; however, the available LiDAR data does illustrate the features (**Plate 2**). However, the feature has not been the subject of detailed archaeological investigation to determine its origin.






Plate 2: LiDAR: 1m DSM with Principal Component Analysis (PCA)

Further evidence of Iron Age activity in the surrounding area has been recorded in the town of Carmarthen in the form of a quern stone (**Figure 5**, **209**). The quern stone was discovered, *c*. 520m south of the Site, built into the wall of a cottage. The stone had a diameter of 40.6cm, 5cm thick, and it had a symmetrically grooved base.

The evidence suggests that the Site has limited potential to contain prehistoric archaeological remains. Prehistoric remains in the study area predominantly consist of cropmarks that potentially relate to prehistoric features. However, these features have not been the subject of archaeological investigations to ascertain their origins, and many of the features appear to have been destroyed by modern agricultural activity. No cropmarks or possible features have been identified within the Site.

4.5 Roman (c. 74 CE – 410 CE)

No Roman features / artefacts have been recorded within the Site.

It is likely that the Romans begun their campaigning into south-west Wales between *c.* 50 CE and 75 CE. A fort at Carmarthen (**Figure 3 & 4, CM235**; **Figure 5, 39 & 92890**), located *c.* 785m south of the Site, was constructed as part of a network of forts established during the rapid conquest of north central and west Wales by Julius Frontinus, Governor of Britain 74 – 77 CE (James 2003, 13). Excavations in the mid-late 1980s recorded Roman features that were interpreted to be part of an auxiliary fort, which later underwent a reduction in size. The finds concur with a Flavian foundation (*c.* 74 – 76 CE) and suggest an early second century abandonment (James 2003, 29).

To the east of the fort, and *c.* 430m south of the Site, was the Roman town of *Moridunum* (**Figure 3** & **4**, **CM234**; **Figure 5**, **69** & **94432**). The town appears to have been around 5.7ha to 6.1ha in size and the outline of the town is captured in the present-day street layout. Richmond Terrace marks the northern boundary, Old Oak Lane the eastern boundary, Esplanade / The Parade the southern boundary, and Little Water Street / Church Street / Parade Road the western boundary. It is likely that *Moridunum* also comprised the *civitas* capital of the Demetae, an Iron Age people who occupied Pembrokeshire and Carmarthenshire (Wacher 1974, 390).

Sections of Roman streets / roads have been recorded during excavations within Carmarthen (**Figure 5**, **21**, **34**, **35**, **36** & **114111**). The excavations have revealed a possible gridded layout to the town's street plan, as is usual with *civitas* capitals, whose elements could all have been in place before the construction of the town defences at the end of the second century (James 2003, 16).



There is no reason to doubt that the town defences (**Figure 5**, **275701**) enclosed most of the occupied area, and that it followed the line of the modern street layout, as discussed above. A small section of the town defences is a Scheduled Monument (**Figure 3**, **CM243**), located north of Esplanade, *c*. 585m south-east of the Site. The construction of the first phase bank and ditched defence can be seen as the final component of an ordered layout; it gave structure and shape to the settlement. Additionally, the provision of defences and elaborate entrances and gateways may have been seen as a mark of status among Iron Age people (James 2003, 18).

The remains of an amphitheatre (**Figure 3**, **CM206**; **Figure 5**, **31** & **303957**) are located c. 250m to the north-east of the boundary of town defences, and c. 500m south-east of the Site (**Photo 30**). The amphitheatre has an elliptical structure, with a long axis of c. 90m and a short axis of c. 60m. Excavations in 1968 and 1970 revealed the course of the arena wall and traces of the eating arrangement, it was estimated that it had a seating capacity of 4,500 - 5,000 people.

There have been many findspots recovered from Carmarthen over the centuries and decades that relate to the Roman town of *Moridunum*. These items findspots comprise building material pottery, bronze objects, and several coins. All these items are included in **Appendix B** and are illustrated on **Figure 5**.

The coins chart the Roman history of *Moridunum*, with the coins dating from the 1st century CE to the late-3rd century CE. The second quarter of the 3rd century saw far-reaching political, social, and economic changes throughout the Roman Empire. At *Moridunum* the changes begun even earlier, with a period of neglect, abandonment, and even demolition of many buildings in the late 2nd century. Much of the central area of the town lay derelict, and though rebuilding eventually followed, the town was never as densely occupied as before (Arnold & Davies 2002, 51).

The evidence suggests that the Site has limited potential to contain archaeological remains from the Roman period. Roman activity was centred on the Roman town of *Moridunum* to the south of the Site, the fort to the west of the town, and the amphitheatre to the east of the town. These remains are located over 500m to the south of the Site and no Roman findspots / features have been previously recorded in proximity to the Site. During the Roman period the Site would have been located beyond the confines of a settlement.

4.6 Early Medieval (410 – 1066)

No early medieval features / artefacts have been recorded within the Site.

There is limited evidence of Carmarthen in the early medieval period; however, there is a tradition that St Teulyddog, a disciple of St Teilo, arrived at Carmarthen during the late 6th century. It is believed that St Teulyddog arrived to either seek the protection of a small Christian community, known as a *clas*, or to convert / attempt to convert the inhabitants of post-Roman Carmarthen (Griffiths 1978, p. 137). During an archaeological excavation in the 1970s, on the site of the later medieval priory of St John (see Section 4.7), a radiocarbon date of *c.* 735 CE was obtained from the primary silt of a ditch. This suggests that there was an early medieval monastic site (**Figure 6**, **71**) in this area, located *c.* 600m south-east of the Site.

The churchyard of St Peter's Parish Church (**Figure 6**, **49244**) comprises a small and prominently raised sub-rectangular churchyard, occupied by the later medieval parish church. The size and form of the churchyard suggests that it may belong to an early medieval church. It is located *c*. 660m south of the Site and immediately within the west gate of the Roman town, possibly hinting at some form of continuing or resumed secular settlement during the post-Roman period.

In the 19th century workmen recovered a copper vessel, dated to the early medieval period, near the walls of the medieval town, *c*. 790m south of the Site (**Figure 6**, **11624**). It was reported that the copper vessel was found at a depth of c. 1m below the foundation of the town wall and in the 'native alluvium'.

The evidence suggests that the Site has limited potential to contain archaeological remains from the early medieval period. Any early medieval activity appears to have been centred on the early medieval predecessor of St John's Priory and the post-Roman town. It is likely that the Site was located beyond the confines of early medieval settlement.

4.7 Medieval (1066 – 1539)

No medieval features / artefacts have been recorded within the Site.



A settlement (**Figure 6**, **10612**), located *c*. 430m west of the Site, is mentioned in the *Carmarthen Cartulary*, which is dated to the 14th century. There is no other mention of the settlement, nor are there any other recorded remains recorded in the HER or NMRW data. Additionally, historic maps, historic aerial photographs, and LiDAR data reviewed for this assessment has not revealed any evidence of a medieval settlement at this location.

Medieval activity is, however, recorded within the town itself. The town was in all probability a centre of a Welsh community which was well established when William fitz Baldwin and his Norman followers arrived in 1094 (Soulsby 1983, 101). Baldwin commissioned the construction of an early castle at Rhyd y Gors (Welsh translation: Ford of the Marsh) perhaps downstream of the current town. There is no trace of this earlier castle and is likely to have been constructed from earth ad timber. The castle was relatively short-lived as Baldwin died in 1096 and around 10 years later the castle was abandoned (Griffiths 1978, 138).

A second Norman castle, Carmarthen Castle (**Figure 4**, **CM008** & **9507**; **Figure 6**, **57** & **95084**) c. 900m south-west of the Site, was constructed under the orders of King Henry I (r. 1100 – 1135) in 1109. It is likely that the castle utilised the decayed defences of the former Roman fort, capitalising on the same advantages that the Romans had appreciated centuries earlier.

The medieval town of Carmarthen was also established following its first grant of privileges from Henry I in 1109. At the same time the existing Welsh settlement to the east, likely centred around the early medieval monastic site attributed to St Teulyddog, was allowed to remain. A royal grant of Henry II (r. 1154 – 1189) led to the established settlement to fall under the control of the St John's Priory (discussed below). Therefore, throughout the medieval period, there were two Carmarthen's: 'New Carmarthen' – the Anglo-Norman borough around the castle, and 'Old Carmarthen' – the Welsh settlement around the early medieval monastic site (Soulsby 1983, 102).

New Carmarthen would have been a walled borough but by the end of the 13th century Carmarthen housed around 150 – 180 burgages. The towns medieval walls and gates (**Figure 6**, **51**, **52**, **53** & **74**) were mostly removed / demolished in the post-medieval period, although small sections are still upstanding.

As discussed above (see Section 4.6), an early medieval monastic site dedicated to St Teulyddog was established c. 600m south-east of the Site. Much of the former priory site comprises a Scheduled Monument and is preserved as Parc Hinds playing fields and an area of allotments (**Photo 31** & **32**).

St Peter's Parish Church (**Figure 4**, **9435**; **Figure 6**, **50** & **100046**), located *c*. 660m south of the Site, is a Grade I Listed Building which consists of various phases of alterations; however, the parish church originates in the 12th century. The location of the church may hint at some form of continuing, settlement at Carmarthen in the post-Roman period.

There have been many findspots and features recorded within Carmarthen from the medieval period. These findspots and features are included in **Appendix B** and are illustrated on **Figure 6**.

The evidence suggests that the Site was located outside of any medieval settlement, likely forming part of the wider agricultural hinterland to Carmarthen at this time. There is limited potential for significant archaeological remains of this date to be present within the Site.

4.8 Post-medieval (1539 – 1900)

No post-medieval features / artefacts have been recorded within the Site.

During most of the post-medieval period, south-west Wales remained a predominantly agricultural area, characterised by scattered isolated farmsteads. Through various Acts of Parliament, between 1750 and 1850, much of the agricultural land in England and Wales was enclosed through Inclosure Acts (Hoskins 1981, 185). The 1839 *Plan of the Parish of St. Peters in the County of the Borough of Carmarthen* tithe map (**Plate 3**) illustrates the Site comprising two parcels of land within an enclosed landscape. It also demonstrates the agricultural nature of the area, and the accompanying tithe apportionment (**Table 1**) provides details of the land within the Site.

The Site and much of the study area comprised agricultural fields. Many of these fields include the word 'parc' or park in English. However, as discussed above (see Section 2.1.4), a visit to Carmarthenshire Archives confirmed that the Site and the surrounding area was not part of an estate. Therefore, it is



likely that the 'parc' has been used to describe pasture / arable land, rather than parkland associated with an estate.



The First Edition Ordnance Survey map of 1888 (**Plate 4**) illustrates the Site in more detail depicting it as comprising two parcels of land, but with a footpath bisecting through it. The footpath is still in use in the present day and a 'kissing gate' is located at the Site's northern boundary with Springfield Road (**Photo 13 & 22**). The Site is immediately adjacent to the Pen-rhos farmstead (**Figure 7**, **114019**), and there are several other farmsteads recorded within both the HER and NMRW data.

The farmsteads further reveal the agricultural hinterland that surrounded the town of Carmarthen throughout the post-medieval period. This agricultural hinterland proved to be prosperous and aided the success of Carmarthen as the region's main market town. As well as agriculture, Carmarthen had a busy river port and from the mid-18th century, iron smelting was being carried out within the town.

The economic prosperity of the town in the post-medieval period, especially the 18th and 19th centuries, led to the construction of amenities for those visiting, i.e., hotels, public houses, shops, etc. Much of the post-medieval HER and NMRW data from within the town centre relate to these amenities. The location of these buildings is recorded on **Figure 7** and listed in **Appendix B**.



The evidence suggests that the Site remained outside of any settlement and continued to be in agricultural use throughout the post-medieval period. Any post-medieval agricultural remains, i.e., field boundaries and ditches, would likely have been truncated / removed by later agricultural activity within the Site.

4.9 Modern (1900 – present)

No modern features / artefacts have been recorded within the Site.

The recorded remains within the study area comprise those related to the development of Carmarthen from the early 20th century onwards. These remains are recorded on **Figure 8** and listed in **Appendix B**.

In the early 20th century, the Site and much of the surrounding area continued to be in agricultural use, as evidenced in the 1906 OS map (**Plate 5**). Aerial photography and satellite imagery charts the development of the Site throughout the mid-20th century and early 21st century. The earliest aerial photography that covers the Site comes from RAF photographs taken in the immediate years following the Second World War (1939 – 1945) (**Plate 6**).








A photograph from 1951 (**Plate 7**) continues to show the Site in agricultural use; however, there are three linear features visible within the photograph (marked with white arrows). LiDAR data covering the Site (**Plate 8**) also illustrates the three linear features within the data. One of the features extends northwards beyond the Site. The size and extent of these features could indicate that they are geological in origin. Additionally, these features do not correlate with field boundaries. The field boundaries illustrated in the historic mapping appear to correlate with the current field boundaries and do not appear to have changed over the last two centuries.

Through the latter half of the 20th century the area surrounding the Site begun to be developed for the residential use. Aerial photography from 1986 (**Plate 9**) shows the residential developments around Courtlands Park and Parc Yr Onen immediately to the west of the Site. The photograph also suggests the beginning of residential development immediately south of the Site for Heol Lluest-Yr-Bryn. The Site still appears to be agricultural use during this period.

The residential development at Heol Lluest-Yr-Bryn was completed by 1992 and the Site continued to be used and maintained for agricultural use. However, by the 2010s, the Site appears to have been taken out of agricultural use and the grass and vegetation had been allowed to grow and was not maintained. A satellite image from 2015 (**Plate 10**) appears to show that the Site had been



predominantly cleared of all grass and vegetation following years of overgrowth. The Site has been left to overgrow again over the last few years as seen during the Site walkover (**Photos 1 – 19**).

5.0 Archaeology: Statement of Significance

This section discusses the significance of the known and potential archaeological remains identified within the Site. The significance of, and potential harm to, historic assets as a result of change to their setting, is then discussed separately in Section 6.

5.1 Significance

Based on an assessment of the Site's topographical and geological profile, HER and NMRW data, historical mapping, additional documentary research, and a consideration of past impacts within the Site area, the Site is assessed to have a limited potential for significant archaeological remains of all dates.

The Site was likely located beyond any settlement throughout the prehistoric, Roman, early medieval, and medieval periods; it was likely in agricultural use during the medieval period, continuing into the post-medieval and modern period. It also remained as agricultural land until the early 21st century when the Site appears to have been taken out of use. Following this, the grass and vegetation had been allowed to grow and was not maintained. In 2015, this grass and vegetation had been cleared but has since been allowed to grow again.

Any agricultural remains, i.e., field boundaries and ditches, would likely have been truncated / removed by modern agricultural practices and / or by the vegetation clearance in 2015. Any post-medieval agricultural remains are unlikely to be of sufficient archaeological interest to qualify as historic assets.

5.2 Impact

5.2.1 Previous On-Site Activity

The Site was in agricultural use throughout the post-medieval period and into the modern period, and it is likely that it has been subjected to varying degrees of ploughing, either through drainage schemes, or the establishment of improved pasture. Such activity, along with the 2015 Site clearance, is likely to have had some impact upon potential buried remains of archaeological interest (if present).

5.2.2 Proposed Development

The development (see **Appendix E**), comprising the construction of 34 residential units, will require the excavations of foundation and service trenches. There will also be groundworks associated with the construction of an access, road, an attenuation pond, the relocation of the public footpath, and any other associated landscaping work required.

These groundworks will have an impact upon the soil profiles within the Site; however, no archaeological features have previously been recorded, or have been identified within the Site through the course of this assessment. Therefore, there is a limited potential for any archaeological remains to exist within the Site boundary.

Nonetheless, Heneb: Dyfed Archaeology recommended that the 2017 outline planning application (reference no.: W/35903) was subject to an archaeological condition. Such archaeological investigation may comprise an initial geophysical survey, any the requirement for additional archaeological investigations (such as trial trenching) would be dependent on the results of said geophysical survey.



6.0 Settings Assessment

This section assesses the potential impact of the proposed development on the significance of designated historic assets through a change to their setting. All designated historic assets deemed to be potentially susceptible in the wider landscape of the Site (**Figure 2**, **3 & 4**) were considered in accordance Cadw's *Setting of Historic Assets in Wales* (2017).

Stage 1 of the Cadw guidance is to identify which historic assets and their settings are affected. The guidance notes that Stage 1 should identify the historic assets which are likely to be affected by any change to their experience, as a result of the development proposal.

A combination of GIS analysis and a Site visit, which has considered, amongst other factors, the surrounding topographic and environmental conditions, built form, vegetation cover, and lines of sight, within the context of the assets' historic significance, has identified that there would be no non-physical impact upon the significance of several historic assets through a change to their setting.

These unaffected historic assets have been scoped out at Stage 1 and include the nearby assets of:

- Parc Cottage (9609), Grade II Listed Building;
- Hendre, including gate and railings (9608), Grade II Listed Building; and
- Wellfield House (9621), Grade II Listed Building.

All historic assets that have been scoped out at Stage 1 are included in Appendix A.

The remaining historic assets that have not been scoped out at Stage 1 have been progressed to Stage 2 / Stage 3 include North Carmarthen Conservation Area which is located adjacent to the Site. Stage 2 considers the contribution that setting makes to the significance of potentially susceptible historic assets. Stage 3 then considers how, if at all, and to what extent, any anticipated changes to the setting of those assets, as a result of the proposed development, might affect their significance.

6.1 North Carmarthen Conservation Area

6.1.1 Description

There are ten Conservation Areas within the Carmarthen area. However, only four Conservation Area Character Appraisals and Management Plans have been undertaken, and these have been for the following Conservation Areas: Carmarthen Town, Lammas Street, Picton Terrace / Penllwyn Park, and Priory Street.⁵ Immediately to the west of the Site is North Carmarthen Conservation Area, though this has not been the subject of an appraisal or management plan.

The North Carmarthen Conservation Area (**Photos 23** – **29**) comprises the late-18th and 19th century residential extension to the town of Carmarthen. It comprises Victorian terraced housing located along Francis Terrace, Barn Road, and Waterloo Terrace, and extends northwards into Wellfield Road, Long Acre Road, and Springfield Road. There is a change in the residential properties in this northern extent of the Conservation Area, where the properties comprise larger detached and semi-detached Victoria villas. These properties appear to reflect the housing designed for the Carmarthen Victorian middle-classes. Two of these larger houses comprise Grade II Listed Buildings, including Hendre (**Figure 3**, **9608**) and Wellfield House (**Figure 3**, **9621**), which are located *c*. 215m south-west of the Site.

There is another subtle change as the Conservation Area extends northwards along Springfield Road and towards the Site. This area is more sparsely populated with residential properties and there is open land to the west of the Conservation Area. There is also another Grade II Listed Building located in this area, comprising Parc Cottage (**Figure 3**, **9609**). To the east, and beyond the Conservation Area, is the modern residential development around Heol Lluest-Yr-Bryn.

6.1.2 Significance

North Carmarthen Conservation Area includes several Listed Buildings. Its significance derives from its architectural, archaeological, and historic values.

A part of the Conservation Area's historic and archaeological value derives from the development of this area of Carmarthen in the late-18th and 19th centuries. It is likely that this area developed here as a result of Carmarthen's expansion in the late post-medieval period and the lack of space in the historic core of Carmarthen. Many of the buildings in the North Carmarthen Conservation Area date to the 18th and 19th centuries. The buildings within the Conservation Area predominantly comprise residential housing, along with chapels and a former school (now council buildings). This area would have been located outside the historic Roman and medieval town defences, and it would have likely been constructed upon former agricultural land. Therefore, the ground within the Conservation Area is not likely to have significant archaeological potential, unlike the historic core of Carmarthen.

The Conservation Area's appearance is characterised by compact streets, comprising for the most-part of ribbon developments along the main roads of Francis Terrace and Wellfield Road. Views out of the Conservation Area are limited due to the dense build-up of residential dwellings. The buildings within the Conservation Area, of which several are Listed (see **Figure 3**), exhibit a range of Victorian styles, of differing scales, but constructed from local stone, with frequent use of render. Much of the Conservation Area dates to the 18th and 19th centuries and many of the buildings have consistent features.

Aspects of the Conservation Area's setting which contribute to its significance include its spatial layout. This urban topographs consists of the compact streets of terraced housing around Francis Terrace and Waterloo Terrace, which transitions to the more spacious streetscape and larger housing along Wellfield Road to the north. Otherwise, setting contributions are limited. In a general sense, the surrounding post-medieval residential areas, and the more historic core of Carmarthen, contribute to an understanding of the area's historical development. Such aspects have been partially eroded by modern developments, and unsympathetic alterations to the existing buildings within the Conservation Area. However, despite this, the Conservation Area retains the greater part of its significance, authenticity, and legibility.

6.1.3 Impact

The proposed development comprises a continuation of modern residential development to the east of the Conservation Area. Modern residential developments to the east of the Conservation Area have been constructed since the 1970s and provide the setting of the surrounding area. The proposed development will only be marginally visible from the northern edge of the Conservation Area, i.e., the northern edge of Springfield Road.

The Site is located outside of the Conservation Area and well-removed from its core (i.e., Francis Terrace and Wellfield Road). While there are limited glimpses to the Site from the Conservation Area (**Photo 24**), and some glimpses into the Conservation Area from the Site (**Photos 8** – **10**), such views make no contribution to the significance of the Conservation Area as part of its setting. These views predominantly comprise views onto Springfield Road and there are no ranging views into the Conservation Area. Also, views to and from the Site and the Conservation Area are filtered by mature trees, vegetation, and the built form along Springfield Road.

This limited intervisibility would not impact upon the key aspects of the Conservation Area's character and appearance, or significance, as outlined above (namely, its planform, scale, and form of development). The proposed development would change the character of the Site, but it would be seen as an extension to the residential development around Heol Lluest-Yr-Bryn. In this context, therefore, the proposed development would not harm the significance of the North Carmarthen Conservation Area; its significance would be preserved. This creates a strong policy presumption in favour of the scheme.

7.0 Conclusions

7.1 Archaeology

Based on an assessment of the Site's topographical and geological profile, HER and NMRW data, historical mapping, other documentary research, and a consideration of past impacts within the Site area, the Site is assessed to have a limited potential for significant archaeological remains of all dates.

No designated historic assets are located within the Site, and therefore, no designated historic assets would therefore be physically affected by the proposed development.

No known or potential non-designated historic assets have been identified within the Site. The Site would have been located some distance beyond the Roman and medieval town of Carmarthen and was likely in agricultural use during the medieval period, continuing into the post-medieval and modern period. The Site remained as agricultural land until the early 21st century when it appears to have been taken out of use. Following this, the grass and vegetation had been allowed to grow and was not maintained. In 2015, it had been cleared but had subsequently been allowed to grow again.

Any agricultural remains, i.e., field boundaries and ditches, would likely have been truncated / removed by modern agricultural practices and / or by the vegetation clearance in 2015. Any post-medieval agricultural remains are unlikely to be of sufficient archaeological interest to qualify as historic assets.

Heneb: Dyfed Archaeology recommended that the 2017 outline planning application (reference no.: W/35903) was subject to an archaeological condition. Such archaeological investigation may comprise an initial geophysical survey, any the requirement for additional archaeological investigations (such as trial trenching) would be dependent on the results of said geophysical survey.

7.2 Heritage

This assessment, undertaken in full accordance with the guidance provided by Cadw, has concluded that proposals would result in no harm to the significance of any historic assets due to a change to setting. Nor would the proposals diminish the ability to appreciate the significance of any nearby historic assets.

Overall, the proposals would be consistent with the provisions of the Planning (Listed Buildings and Conservation Areas) Act (1990) Section 66(i), Historic Environment (Wales) Act 2016, Planning Policy Wales, as well as policies contained in Local Development Plans.

























Appendix A Gazetteer of Designated Historic Assets Assessed to Stage 1



A.1 Stage 1 Assessment

The historic assets, listed in the table below, have been assessed to Stage 1 of Cadw's *Setting of Historic Assets in Wales* (2017). Several other historic assets have been assessed in further detail (see Section 6 above). However, it has been concluded that the historic assets listed below would not be affected by the proposals.

In all instances, there is a lack of any material inter-visibility between them and the Site, a lack of any relevant non-visual association(s) between them and the Site, lack of any 'third points' from which both would be visible to a material extent within the same view-shed, and in some cases, there is great intervening distance(s) between the historic assets and the Site.

As such, this negates the potential for development within the Site to adversely affect their significance. Similarly, the ability to appreciate their significance would be unaffected by development within the Site of the nature and on the scale proposed. The key contributing heritage values to the significance of these historic assets, the ability to appreciate their significance, and all key views towards, from and including them, would be preserved.

1.0 Introduction

SLR Consulting Limited (SLR) has been commissioned by Obsidian Developments Ltd (the Client) to prepare a Written Scheme of Investigation (WSI) setting out the scope and methodology for an Historic Environment Desk-Based Assessment (HEDBA) for a development on land at Heol Lluest y Bryn, Carmarthen, SA31 1GZ (NGR: SN 41463 21005) (**Figure 1**; henceforth 'the Site).

This WSI has been guided in its composition by the *Standard and guidance for historic environment desk-based assessment* (ClfA 2020a), Planning Policy Wales (Welsh Government 2024), and Technical Advice Note (TAN) 24: The Historic Environment (Welsh Government 2017). This WSI will be the subject of approval by the Archaeological Planning Manager / Archaeological Planning Officer at Heneb – The Trust for Welsh Archaeology: Dyfed Region (formerly Dyfed Archaeological Trust), to seek agreement on the scope and methodology of the project, prior to undertaking the assessment. Upon completion, a copy of the document will be sent to Heneb and the Royal Commission on the Ancient and Historical Monuments of Wales (RCAHMW) for deposition.

2.0 Planning Background

The Client submitted pre-application advice to Carmarthenshire County Council (CCC) on 29th January 2024 (reference no.: PRE/02018). The proposed development comprises a residential development of 33 residential units, together with access, landscaping, and associated works. The pre-application response from CCC stated that:

The proposed development is in close proximity to the North Carmarthen Conservation Area and has the potential to have a detrimental impact on its setting if not considered and designed appropriately. A Heritage Impact Assessment would be beneficial in support of any application. It is also noted that in general the proposed site has what appears to be a historic path running through its centre with traditional wrought iron swing gates leading onto Springfield Road. It is advised that it would be considered appropriate to conserve this feature as part of any development proposed.

3.0 Objectives

The assessment will fully assess the known and potential historic assets within the Site, their survival and significance. The objectives of the HEDBA will be:

- to identify designated heritage constraints within the Site and study area;
- to gather information on non-designated recorded historic assets through desk-based research, and through available archaeological survey information;
- to assess the above baseline information, and offer an analysis of the potential for currently unrecorded historic assets within the Site;
- to assess, as far as possible, the likely depth and extent of any below-ground archaeological deposits within the Site; and
- to assess the value of the historic assets affected by the proposed development and, where possible, the impact of the proposed development upon the value of these assets, including the setting of both designated and non-designated historic assets.

4.0 Methodology

4.1 Key Heritage Policy & Guidance

The content, aims and method set out in this WSI have been guided by the following key documents:

- Planning Policy Wales (Welsh Government Edition 12, 2024);
- Technical Advice Note (TAN) 24: The Historic Environment (Welsh Government 2017);
- Conservation Principles (Cadw 2011);
- Standard and guidance for historic environment desk-based assessment (ClfA 2020a);
- Setting of Historic Assets in Wales (Cadw 2017);
- Research Framework for the Archaeology of Wales; and
- The Guidance for the Submission of data to the Welsh Historic Environment Records produced by the Welsh Archaeological Trusts (2022).

4.2 Desk-Based Assessments

The desk-based research and sources will be based upon the *Standard and guidance for historic environment desk-based assessment* produced by the Chartered Institute for Archaeologists (2020a). The archaeological assessment will utilise a minimum study area of 1km around the boundary of the proposed Site. Data will be collated from published and archive sources of archaeological, historical, geographical, topographical, and environmental information relevant to the area of the development using the following sources:

- Cadw for details details of designated historic assets including Scheduled Monuments, Listed Buildings, etc.;
- the Heneb The Trust for Welsh Archaeology: Dyfed Region Historic Environment Record (HER) for details of previously completed archaeological works in the vicinity and recorded historic assets:
- the Royal Commission on the Ancient and Historical Monuments of Wales (RCAHMW) for additional details of recorded historic assets;
- aerial photographs from the Welsh Governments Aerial Photographs Officer;
- the Carmarthenshire Archives for documentary sources and historic mapping of relevance to the historical development of the Site and its surroundings;
- remote sensing resources, i.e., LiDAR data (provided by the Data Map Wales website); and
- relevant national and local planning policy documentation.

A walkover survey would also be undertaken to inform the HEDBA. The walkover survey would comprise two stages. Firstly, the Site would be visited and the whole area would be subject to a walkover to assess and document any extant evidence of historic assets, any evidence of previous disturbance within the Site, and the setting of historic assets. The second phase of the survey would comprise the walkover of the study area, considering all historic assets and potential impacts upon their setting. Photographs and notes would be taken during the walkover survey, and where necessary, included within the HEDBA.



4.3 Value of Historic Assets

The value of historic assets is best defined by the Cadw guidance, *Conservation Principles* (2011), which describes value as a combination of evidential value, historical value, aesthetic value, and communal value.

Evidential value derives from those elements of an historic asset that can provide evidence about past human activity, including its physical remains or historic fabric.

Historical value may derive from aspects of past ways of life, or association with notable families, persons, events, or movements – it embodies the connection between past events and society with the present.

Aesthetic value derives from the sensory and intellectual stimulation drawn from an historic asset. It may include its physical form, and how it lies within its setting. It may also be the result of design, or an unplanned outcome of a process of events.

Communal value derives from the meanings that an historic asset has for the people who relate to it, or for whom it figures in their collective experience or memory. It may be commemorative or symbolic and relate to issues of identity or collective memory.

4.4 The Setting of Historic Assets

The assessment will be undertaken in accordance with the approach outlined in Cadw's Setting of Historic Assets in Wales (2017). This publication provides guidance on setting and development management, including the assessment of the implications of proposed development. It reiterates that 'the setting of a historic asset is the surroundings in which a historic asset is experienced. Its extent is not fixed and may change as the asset and its surroundings evolve. Elements of a setting may make a positive or negative contribution to the significance of an asset, may affect the ability to appreciate that significance or may be neutral'. In accordance with the guidance, the extent of the setting of a historic asset is not fixed and can evolve periodically.

All historic assets have a setting, and features of a setting may make a positive or negative contribution to significance and may affect the appreciation of the asset. They can remain neutral. The extent and importance of setting is often expressed by reference to visual considerations but can also comprise other elements which contribute to the ways in which a historic asset is experienced, including factors such as noise, vibrations, dust, or other pollutants; spatial associations; the rarity of comparable survivals of setting, and associative relationships between historic assets.

5.0 Staff & Timetable

The assessment will be carried out by James Evans, ACIfA, Senior Archaeology and Heritage Consultant, SLR Consulting, and it will be technically coordinated by Dr Emma Wells, MCIfA, FSA, Technical Director – Archaeology and Heritage, SLR Consulting.

The data collation, analysis and assessment report normally take approximately five weeks.

6.0 Analysis & Reporting

The information collated will initially be assembled into a workable database, cross-referenced to the original sources. The assessment report will begin with a non-technical summary both in English and Welsh, in accordance with *Guidance for the Submission of Data to the Welsh Historic Environment Records* (WAT 2022), outlining in plain language the principal reasons for the work, its aims and main results. The introduction will then set out the circumstances leading to the commission of the report, any restrictions on reporting or access to relevant records, size, surface geology and topography of the study area. 


