

GREENLIGHT COMMITTEE CHARTER OF

THE INFINIT FOUNDATION, INC.

"The elders who are among you I exhort, I who am a fellow elder and a witness of the sufferings of Christ, and also a partaker of the glory that will be revealed: Shepherd the flock of God which is among you, serving as overseers, not by compulsion but willingly, not for dishonest gain but eagerly; nor as being Lords over those entrusted to you, but being examples to the flock; and when the Chief Shepherd appears, you will receive the crown of glory that does not fade away."

I Peter 5:1-4 NKJV

ARTICLE I PURPOSE

The Greenlight Committee ("Committee") of The Infinit Foundation, Inc. ("Foundation") is established to ensure that all written, filmed, and interactive content produced or distributed by the Foundation aligns with its mission to teach and edify the global community in the Gospel of Jesus Christ. Drawing inspiration from 1 Peter 5:1-4, the Committee is tasked with shepherding the Foundation's content with diligence, integrity, and a commitment to spiritual oversight.

ARTICLE II RESPONSIBILITIES

- 1. Content Review: The Committee shall review all content proposals, including but not limited to screenplays, novelizations, interactive content (such as video games and virtual reality applications), and motion pictures, to evaluate their alignment with the Foundation's mission.
- **2. Mission Alignment:** Content must deeply resonate with the teachings of Jesus Christ, promoting spiritual growth and understanding among consumers.
- 3. Scriptural Basis: In accordance with 1 Peter 5:1-4, the Committee will act as elders, overseeing content with willingness, not for personal gain, but to eagerly fulfill Christ's Great Commission.

4. Decision Making: The Committee will make decisions to greenlight content based on its potential to contribute significantly to the teaching and edification of its audience in the Gospel.

ARTICLE III

COMPOSITION AND STRUCTURE

The Committee will be composed of no less than 3 and no greater than 12 members appointed by the Board of Directors, ensuring a diverse representation of expertise in theology, media production, and content distribution. Members are required to adhere to the Foundation's Conflict of Interest Policy and may be asked to sign a Non-Disclosure Agreement to protect sensitive information.

ARTICLE IV PROCEDURES

- **1. Submission Review:** Content creators affiliated with the Foundation will submit their proposals to the Committee for consideration.
- **2. Evaluation:** The Committee will evaluate submissions based on scriptural integrity, theological depth, and the creative quality of the content. A reasonable time limit will be set for the review of each submission, commensurate to the length of the material.
- **3. Decision and Feedback:** Decisions to greenlight projects will be communicated to the submitter, along with any feedback or conditions for approval.
- **4. Documentation:** All decisions and deliberations will be properly documented and archived in accordance with the Foundation's record-keeping policies.

ARTICLE V AMENDMENTS

This charter may be amended or revised by the Board of Directors to reflect changes in the Foundation's strategic direction or in response to feedback from the Committee, content creators, and the Foundation's community.

ARTICLE VI

ADOPTION OF THE GREENLIGHT COMMITTEE CHARTER

This charter is hereby adopted by the Board of Directors of The Infinit Foundation, Inc. on March 7th, 2024, signifying our commitment to producing content that faithfully represents the Gospel of Jesus Christ and serves the spiritual needs of our audience worldwide.
