## EXECUTIVE SUMMARY

The third quarter of 2025 reflects meaningful advancement across The Infnit™ Foundation. Eternity Chapel expanded its ministry with the launch of a new 11 a.m. Sunday service, which welcomed new worshippers and saw multiple responses to the Gospel. In addition, Worship Night Wednesdays were introduced, incorporating live instruments and extended worship. With these additions, Eternity Chapel now hosts five weekly gatherings, having welcomed more than 8,000 unique guests and conducted over 200 services since launch.

Development of Infnit™ Dominion continued forward as hyper-real environments were integrated into an increasingly immersive virtual world. A public preview demo was released this quarter, offering a first look at the evolving experience.

As we conclude the third quarter of 2025, I am filled with gratitude for the continued growth and spiritual fruit happening across The Infnit™ Foundation.

#### Eternity Chapel: Expanding Reach

Eternity Chapel continues to grow in both reach and spiritual impact. This quarter, we launched our new 11 a.m. Sunday service, which—on its first day—welcomed new worshippers and saw multiple responses to the Gospel.

We have also introduced Worship Night Wednesdays, featuring live instruments and extended times of praise. These gatherings have already become a source of renewal and fellowship for many.

With these additions, Eternity Chapel now hosts five weekly gatherings, welcoming a global congregation. To date, we have seen over 8,000 guests and celebrated more than 200 services since inception. Each service further confirms that God is using this ministry to reach hearts that might never otherwise hear the Gospel.

#### Infnit™ Dominion: Immersion Takes Shape

Development of Infnit™ Dominion continues forward as we incorporate hyper-real environments into an increasingly immersive virtual world. The creative thresholds being reached in Unreal Engine are giving shape to environments unlike anything we've built before.
