## EXECUTIVE SUMMARY

Our fourth quarter reflects continued momentum across The Infinit™ Foundation's creative and ministry initiatives. Production began on *Project Forevermore*, an AI-driven film initiative designed to establish a scalable production pipeline for future Infinit theatrical releases. This milestone marks a significant step forward in expanding the Foundation's storytelling capabilities through emerging technologies.

Development of *Infinit™ Dominion* progressed further this quarter, with continued integration of hyper-real environments into an immersive virtual reality experience. These advancements strengthen the foundation of a living digital world that blends creativity, narrative depth, and spiritual purpose.

**Eternity Chapel** extended its worship ministry beyond live services with the release of *Grace Runs Deeper* and four accompanying variations across all major music marketplaces. Originally written and sung for service, the release allows worship to reach audiences well beyond the virtual sanctuary.

Work on **Book Three** of The Infinit™ Universe remains ongoing, with development continuing prayerfully and intentionally as the next chapter of the series takes shape.
