#### **EXECUTIVE SUMMARY**

The second quarter of 2025 marks continued growth and spiritual impact across The Infinit™ Foundation. Eternity Chapel launched a new 11 a.m. Sunday service, resulting in multiple salvation responses and deeper community engagement across its VR and mobile gatherings. With **three weekly services** now in place, Eternity Chapel continues to redefine what it means to be the Church in a digital world.

Development of Infinit<sup>TM</sup> Dominion advanced significantly this quarter, incorporating hyperrealistic environments to elevate its immersive, Gospel-driven experience. Built in Unreal Engine 5.5, the virtual theme park is pushing the boundaries of visual and spiritual storytelling.
