EXECUTIVE SUMMARY

This year marked a season of transition and tangible progress for The Infinit™ Foundation, as several initiatives moved from vision into active production. A major milestone was the official greenlighting of **Book One** of The Infinit™ Universe for future adaptations across animated, audio, and live-action formats, while development of **Book Three** continued prayerfully and intentionally. Production also began on **Project Forevermore**, an AI-driven film initiative establishing the foundation for a scalable theatrical production pipeline.

Infinit™ Dominion officially entered production following completion of a comprehensive development document and is now being built in **Unreal Engine 5.6** as an immersive, cross-platform virtual theme park. **Eternity Chapel** continued to serve as the spiritual heartbeat of the Foundation, expanding to five weekly gatherings and welcoming more **than 8,000 guests** across over **200 services**. Worship also extended beyond live services with the release of **Grace Runs Deeper** across major music platforms. Together, these advancements reflect a year of faithful growth, creative innovation, and continued commitment to sharing the Gospel through excellence and technology.

FROM THE CEO

As we reflect on this past year at The Infinit™ Foundation, I am filled with deep gratitude for the faithfulness of God and the steady progress He has allowed across every area of our mission. This year was marked not only by expansion, but by transition—moving key initiatives from vision into production and laying groundwork that will shape the years ahead.

From the beginning, The Infinit™ Foundation has existed to share the Gospel through creativity, technology, and storytelling. Over the course of this year, that vision continued to mature into tangible outcomes, confirming that God is establishing something enduring through this work.

One of the most significant milestones this year was the official greenlighting of **Book One** of The Infinit™ Universe for future production. Following a successful review by our **Greenlight Committee**, this foundational story has now been approved for expansion across multiple formats, including animated, audio, and live-action adaptations. This decision unlocks new opportunities to carry its Gospel-centered message to broader audiences while maintaining the theological heart at the core of the story.

Development of **Infinit™ Dominion** also reached a defining turning point. With the completion of a comprehensive 72-page development document, the project officially transitioned from concept into active production. Using **Unreal Engine 5.6**, an expansive virtual theme park has been under construction, designed to function across PC, mobile, VR, and major consoles. From asset creation to immersive level design, **Infinit™ Dominion** is taking shape as a first-of-its-kind destination where entertainment and faith-driven storytelling intersect. Strategic

investments in hardware this year have further positioned us to meet the creative and technical demands of this ambitious undertaking.

Throughout the year, **Eternity Chapel** continued to grow as the spiritual heartbeat of The Infinit™ Foundation. The launch of a new 11 a.m. **Sunday service** expanded accessibility and resulted in immediate Gospel responses. **Worship Night Wednesdays** were also introduced, featuring live instrumentation and extended worship, fostering deeper fellowship and spiritual renewal. With five weekly gatherings now in place, Eternity Chapel has welcomed more than **8,000 guests** and hosted over **200 services** since inception—reaching individuals around the world who may never otherwise step into a traditional church setting.

This year also saw Eternity Chapel's worship extend beyond the virtual sanctuary. The release of **Grace Runs Deeper**, along with four variations, across all major music marketplaces transformed a song born in service into a tool for daily ministry. It has been humbling to witness worship travel into homes and personal moments—affirming that ministry multiplies when obedience meets opportunity.

Creative innovation continued to expand with the launch of **Project Forevermore**, an AI-driven film initiative now in active production. While still in its early stages, this project represents an important step toward establishing a sustainable production pipeline for future Infinit theatrical releases. It has already begun shaping how we approach scalability, storytelling, and emerging technology in service of truth.

Meanwhile, work on **Book Three** of The Infinit™ Universe remains underway. This next chapter is being developed prayerfully and intentionally, with a continued commitment to weaving biblical truth into imaginative worlds that engage hearts and minds across generations.

As we look ahead, this year stands as a testament to God's guidance and provision. What began as vision continues to solidify into structure, systems, and creative output—all anchored in the mission to glorify Christ. None of this would be possible without the prayers, encouragement, generosity, and trust of our donors, volunteers, and supporters.
