### 2. Information We Collect

#### Personal Details

We may collect:

- Name
- Email address
- Phone number
- Date of birth (age verification)

- Address
- Emergency contact details

## Driver & Vehicle Information

For competitors and entrants:

- Driver licence details
- Vehicle make, model & specifications
- Registration number
- Competition number
- Vehicle photos
- Insurance details (if provided)
- Scrutineering information

## Event & Incident Records

We may record:

- Entry forms
- Waivers
- Incident reports
- Safety breaches
- Disqualifications
- Medical or first-aid attendance (limited to incident documentation)

## Automatically Collected Data

When using our website:

- IP address
- Browser/device information
- Cookies and analytics

## 3. Filming & Photography (Important)

Our events are **public entertainment motorsport events**.

We actively film and photograph:

- Vehicles
- Number plates
- Drivers
- Passengers
- Spectators
- Crashes, fires, and mechanical failures
- Crowd reactions

This media may be used for:

- Social media
- Livestreams
- Advertising & promotion
- Sponsors and partners
- Television or media outlets
- Future event promotion
- Monetised online content

Attendance at the venue constitutes consent to being recorded in a public setting.

You may request removal of identifiable close-up images where reasonable, however event footage documenting the event itself may be retained.

## 4. How We Use Information

We use personal information to:

- Register entrants
- Verify age & licensing
- Conduct safety checks
- Run competitions
- Contact participants
- Manage incidents and safety compliance
- Provide footage to media partners
- Promote events
- Prevent dangerous behaviour
- Comply with legal and insurance obligations

We do **not sell personal contact details**.

## 5. Sharing Information

We may share information with:

- Track owners and venue operators
- Emergency services and medical staff
- Motorsport officials and safety officers
- Insurance providers
- Sponsors and media partners (footage only)
- Government authorities if required by law

## 6. Data Storage & Security

Information is stored digitally and/or physically using reasonable safeguards to prevent misuse, loss, or unauthorised access.

Because motorsport events involve legal and insurance risk, some records may be retained long-term.

## 7. Data Retention

We may retain:

- Waivers and entry records — long term for liability purposes
- Incident reports — long term for legal protection
- Event media — indefinitely as historical media archive

## 8. Your Rights

You may request to:

- Access your personal information
- Correct inaccurate details
- Withdraw marketing consent
- Request removal of certain identifiable images (where reasonable)

## 9. Marketing Communications

We may send event announcements and promotions.
