BYLAW NO. 2021-05

A BYLAW OF THE VILLAGE OF KILLALY TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND SEWER.

COUNCIL of the Village of Killaly, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Municipality's water supply system shall make application to the officials of the Municipality. Each application shall be accompanied by the payment of a non-refundable connection fee as set forth in Schedule "A" hereto attached.
2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "B" appended hereto;
3. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "C" appended hereto.
4. All Accounts for water service shall be subject to a recycling levy in accordance with Schedule "D" appended hereto;
5. Accounts for water service and/or sewer service shall cover a period of three (3) successive months and shall be paid within a period of thirty days after the date on which such accounts are rendered.
6. Any account unpaid after thirty days after the date on which such accounts are rendered shall be subject to a 2% monthly interest charge on their account.
7. If an account is not paid within the period of thirty days, the water service may be cut off any time after that period if the amount is still outstanding. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of **Fifty (\$50.00) Dollars** to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be **Seventy-five (\$75.00) Dollars** for reconnection.
8. The Municipality may ration or limit the amount of water furnished to any and/or all consumers should circumstances deem to warrant such action.
9. Bylaw No. 2019-01 is hereby repealed. This bylaw will go into effect December 16, 2021.
10. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

One or two residents in a unit/apartment: \$35.25/unit/apartment
Two or more residents in a unit/apartment: \$35.25/unit/apartment
