This corporation is a nonprofit public benefit corporation for 'no private main of any person. It is expensed and is not organized/under the Nonprofit Public Benefit Corporation

Law for public and charitable purposes. The public purposes for which the corporation is organized include the construction for operation of a senior citizen's activity center in Elk Grove.

III


