- 4. The Dog is in good health and free of communicable diseases at the time of this sale. Buyer has 3 days from the delivery date to have the Dog examined by a licensed veterinarian, at Buyer's sole cost. If the Dog fails the examination, Buyer may return the Dog, with a written statement from the veterinarian, for a full refund. Failure by Buyer to have the Dog examined within the 3-day period will nullify this warranty. If Buyer chooses to keep the puppy, no replacement will be given, and all medical costs and treatment are sole responsibility of the Buyer. This health guarantee will be null and void.
- 5. Seller will NOT replace a puppy due to heat stroke, abuse/neglect, or improper socialization. The buyer is responsible for all medical costs of their puppy. (No refunds will be given) This guarantee covers only the original Buyer and is not transferable.
- 6. Breeder does not guarantee the puppy to be without hereditary defects. We do our best to avoid passing along any undesirable characteristics which is why we have our dogs tested for such traits.
- 7. To ensure that Buyer does not euthanize the Dog or take it to an animal shelter, Seller will take the Dog back at any time during the Dog's lifetime. Seller will not issue a refund or provide another Dog to Buyer unless the Dog's return was a result of any misrepresentation on the part of Seller with respect to the Dog's health.

Fitness of Purpose

The Dog was bred as a companion animal, and the Seller does not provide any warranty as to the Dog's fitness for any specific purpose, including obedience trials, show ring performance, and/or breeding purposes.

Buyer's Representations

Buyer represents to Seller that:

- 1. Puppies sold with limited AKC, the buyer will have the Dog spayed or neutered by the age of 12 months. Proof must be sent to the breeder. Failure to comply, a \$3,000.00 fine will be assessed, along with any legal fees. Absolutely no breeding is allowed for puppies with limited AKC, these puppies are sold as family members only. If it is found that the dog with limited AKC was bred (Pure or Mixed) the dog will be confiscated by the seller, at the buyer's expense plus all legal fees, along with a \$10,000 fine.
- 2. The Dog will reside with Buyer as companion pet to Buyer and Buyer's family.
- 3. Buyer will keep the Dog in an enclosed area of adequate size. Buyers will not keep the Dog chained or tethered or permanently housed in a kennel.
- 4. Buyer will provide the Dog with nutritious food and necessary veterinary care, including deworming, heartworm prevention and regular vaccinations (including rabies).

- 5. Buyer is not acting as agent for any other person or business in the purchase of the Dog.
- 6. Buyer will not sell, give, or release the Dog to a pet shop, retail store, dog dealer, animal testing facility, research facility, or an agent for any such business or facility. 7. In the event Buyer sells the Dog to a new owner, Buyer shall ensure that the new

owner agrees in writing to comply with the terms of this Agreement.

The Following will Void all and any Guarantee

- 1. The dog shows neglect or abuse.
- 2. The dog has experienced previous trauma (broken bones)
- 3. The dog wasn't given proper veterinary care and fed high quality dog food.
- 4. The dog shows signs of lack of nutrition or obesity.

Limitation of Action

Any action or claim brought by Buyer against Seller for breach of this Agreement or for loss due to negligence must be brought within one (1) year of the date such claim or loss occurs.

Governing Law
