The Wolf Township Board of Supervisors Regular Meeting was called to order at 7:00pm by Chairman, William DeWire at the Township Building. After the Pledge of Allegiance roll call was taken and a quorum was declared. Supervisors attending were Bill DeWire, Dean Barto and Charlie Hall. Melanie McCoy-Secretary/Treasurer attended the meeting.

**Minutes:** A **MOTION** was made by Dean Barto and seconded by Charlie Hall to approve the minutes from the Regular Meeting held July 10, 2017 and Public Hearing for amendments to the Code of Ordinances. Motion approved.

**Solicitor:** Mr. Wiley sent a letter to Scott T. Williams on July 27 explaining the board's decision concerning the vacating of Race Street. He has not received a response. Hughesville Borough and their solicitor were copied on the correspondence.

**Roadmaster:** Paving was completed last month and the chipping was done last week. Waiting on the fog seal and then the lines will be painted.

**Secretary/Treasurer:** The Secretary is looking for waste removal personnel and checking on prices for the Nottingham property. The Township is working with Code Inspections and DEP on this complaint.

Code Publishing has the Township's website up to date with the four new ordinances passed at the last meeting.

**Sewer Authority Report:**

The manhole at the East Lycoming Shopper on Rte. 405 has been fixed and is guaranteed for a year. Dave Walters from Larson Design did research and found Mr. Rehab, with a good reputation. Getting bids for the Gregg Run project, plan to complete this work before winter.

Charlie Hall made a **MOTION** to appoint Josh Hackenberg to the Planning Commission to replace Ms. McCoy. Motion carried.


