

Wolf Township Supervisors – Regular Meeting – December 10, 2018

The Wolf Township Board of Supervisors Regular Meeting was called to order at 7:00pm by Chairman, Dean Barto at the Township Building. Roll call was taken and a quorum was declared. Supervisors attending were Dean Barto, Dave Thomas and Gregg Clayton. Mike Wiley – Solicitor and Melanie McCoy-Secretary/Treasurer attended the meeting.

Visitors: Rick Marsh

Minutes: A MOTION was made by Gregg Clayton and seconded by Dave Thomas to approve the minutes from the Conditional Use Hearing and Regular Meeting held November 12, 2018. Motion approved.

REPORTS OF OFFICIALS AND COMMITTEES

Code Enforcement: Monthly report distributed to the Board.

Planning Commission: Meeting was cancelled, no agenda items.

Solicitor:

Mike Wiley reported that a Preliminary Injunction was filed on November 9th against Harry White stipulating that he had 20 days to abate the storage and parking violations on the property. He could continue with internet sales but not at his property. He was permitted one delivery truck per day.

The 20 days has been reached with no improvement. Mr. White is now in contempt of court. He did supply titles to the vehicles on his property.

Mike Wiley also filed a judgment for the original fine Judge Kemp issued for the first violation that was filed against Mr. White. The Board agreed that Mr. Wiley should go forward with a Writ of Execution for the fine.

Roadmaster:

Gregg attended the COG meeting where a discussion was held concerning the line painters, O.H.Striping, Inc. and their 100% failure to meet the contract. Mr. Wiley will have documents for the COG meeting next Tuesday, concerning the performance bond and addressing the damage clause in the contract.

Sewer Authority Report:

Rick Marsh reported they finally have gone under their permitted 600,000 gallon permitted capacity and have satisfied DEP concerns. Repairs have been made to three lines on Logan Lane by Mr. Rehab. The overtures were due to leaks and sump pumps.

OLD BUSINESS:

The appointment to the Water Authority Board will be made in January.
