The meeting was called to order at 7:05PM by Dean Barto and roll was taken. Supervisors attending were Dean Barto, Gregg Clayton and David Thomas. A quorum was declared. Dean Barto made a **MOTION** to approve Holidays, seconded by David Thomas. Motion carried.
