The Wolf Township Board of Supervisors Regular Meeting was called to order at 7:00pm by Chairman Dean Barto, Vice-Chairman, David Thomas at the Township Building. Supervisor attending was Gregg Clayton. Jennifer Mausteller-Secretary attended the meeting.

**Minutes:** A **MOTION** was made by David Thomas seconded by Gregg Clayton to approve the Regular Meeting minutes held on August 9, 2021. Motion Carried.

**REPORTS OF OFFICIALS AND COMMITTEES**

**Roadmaster:**

Penn Dr Bridge replacement set to be completed in 2022 will require ROW agreements with a few of the neighbors. Letters will be mail to neighbors requesting a meeting with Roadmaster and Engineer.

All Paving and Seal Coating have been completed in the Township. Line Painting should be completed in the next two weeks.

A **MOTION** was made by David Thomas and Seconded by Gregg Clayton to pave the small portion on Railroad St. at the approximate cost on \$4500.00 in junction with the Hughesville Borough. Motion Carried.

**Sewer Authority Report:**

Mr. Marsh said bids have been accepted and are being reviewed by engineers on pump station replacement. Roughly costing the authority \$110,000.00.

**Water Authority Report:**

Bill Edner reported that Bids were accepted on the water tower to be placed on Reservoir Rd. The County also awarded the bid from Hawbaker's for Creek Bank repairs.

Township received a letter from Attorney Williams regarding Race Street abandonment on behalf of the Water Authority. Township will reach out to utilities.

**NEW BUSINESS:**

2020 Census numbers were released, Wolf Township now has a population of 3,105. Up 6.8 percent from 2010.

The Board will support the ELSD sending a letter to Penn Dot regarding the 118 Hwy and Clarkstown Rd intersection for a traffic study to be completed.

**Old BUSINESS:**

A MOTION was made by David Thomas and seconded by Gregg Clayton to approve the HVFD to charge \$50.00 for lift calls within Wolf Township. A letter will be mailed to residents in fall/winter. Motion Carried.

**FINANCIAL REPORT**
