



# 2026 Pe Ell 4<sup>th</sup> of July Festival Vendor Registration

**Deadline for registration: June 30<sup>th</sup>, 2026**

**\*This is your REGISTRATION FORM and CONTRACT. Keep a copy for your records\***

**-No late registrations will be accepted after June 30<sup>th</sup>.**

We greatly appreciate your timely registration to ensure proper placement.

-The Pe Ell 4th of July Festival does NOT require a vendor to have a business license- although it is highly recommended. Food vendors are REQUIRED to hold a current health card from WA State Department of Health. A copy of your health card is required to be submitted with your application. We recommend obtaining a Lewis County Temporary Food Establishment Permit.

**-EVENT IS HAPPENING RAIN OR SHINE. SPOTS ARE FIRST COME FIRST SERVE.**

This is a two-day event: **July 3<sup>rd</sup> & 4<sup>th</sup>, 2026**

**-Check-In:** Please check in at the Vendor Table located at 206 Main St. in Tank Park.

-Booth Set up is between 2-4pm on July 3<sup>rd</sup>, and 7-9am July 4<sup>th</sup>. Booths must be completed no later than 4pm on July 3<sup>rd</sup>, or 10am on July 4<sup>th</sup>.

\*Vendors are responsible for setting up and tearing down their booth.

\*All booth displays MUST BE FREE STANDING.

\*Booths can be dismantled after 3pm on July 4<sup>th</sup> but they are encouraged to stay longer if you're comfortable. Packing up before 3pm will result in possible denial of future applications.

-Vendors understand that No Shows/No Calls on the day of the festival will result in no refund of the registration fee and possibly being denied applications for future festivals. A simple text or email stating you cannot make it, will suffice.

-Vendors understand that once this form is submitted with fee, they will be emailed an invoice for record via the email provided on this form the week before the event.

\*If there are any issues with your submission or you are declined a spot you will receive an email explaining the reason for denial instead of an invoice.

\* Vendors understand that the fee payment is due with this registration.

\*Payment can be made in the form of certified check, money order, or online payment option via our website \*additional fee's may apply\*. Do not mail cash.

**Checks can be made out to Pe Ell 4th of July.**

\*If your payment is not received with your registration your spot will not be secured until payment is received.

\*Refunds will not be given after **July 1st, 2026**.

\*If the Pe Ell 4th of July Festival is canceled for any reason you will receive a full refund of your registration fee.

-Vendors understand that they are to provide their own tables, chairs, canopy weights, and anything needed for booth set up.

\*Vendors are to clean up their booth area and return it to its original condition. This means all trash, debris from your decorations, etc. must be cleaned up prior to leaving the venue.

**\*Disposal of garbage is the vendors responsibility.**

-Approximately 1 week prior to the event vendors will receive an email with set up instructions. This includes your spot assignment and a map location of vendor booths.

-Any festival-day deviations from the originally accepted registration, violations of the stated guidelines, or inappropriate behavior could result in your denial from further festival events.

\* Negativity and fighting will not be tolerated at festival events and will result in not being allowed back.

-The Pe Ell 4th of July Festival does not accept responsibility for traveling expenses, food, lodging, or any other expenses of the registering vendor.

### **Garbage, Grease, and Damages:**

- Disposal of garbage is the vendors responsibility.

- Vendors with food booths that have grease laden vapor are required to have a class K fire extinguisher.

- All grease-related booths must dispose of their own grey water or grease.

- Grease spots in booth area will be assessed by the committee and incur possible damage charges to the vendor.

### **Vendor Registration:**

Booth placement will not be guaranteed until your registration is submitted and full payment is received. The Pe Ell 4th of July Festival Committee has full authority to place booths for the best interest of the event. No placement is guaranteed. We DO NOT offer exclusivity but we DO try to limit duplicate booths.

## Thank you for joining us in 2026 for our 32<sup>nd</sup> year of the Pe Ell 4<sup>th</sup> of July Festivities.

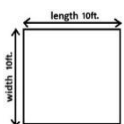

Spaces are 12ft wide and 12 ft deep and are spaced to fit a 10ft. x 10ft. canopy.



Each **10ft. x 10ft.** vendor space, for a **self-sufficient vendor**, is **\$45 for the 2 day event.**

Each **10ft. x 20ft.** vendor space, for a **self-sufficient vendor**, is **\$90 for the 2 day event.**

**1 day event fee is \$45 for all spaces sizes.**
