THE PLATFORM



The LendersConnect platform is a user-friendly interface accessible via website browser or mobile device. After creating a profile, users can connect with other users, forming *Connections*, which can then be available for in-app messaging, access to contact information, etc. Each feature can be searched using a robust search engine to locate resource providers in a certain “state” or “service area” for example, or users who are all “lenders”. Looking for a recently updated SBA form or procedural notice? The **Resources** feature contains a searchable database in order of most recently released.

The **Upcoming Events** features a listing of industry related events across the country, including SBA webinars, LendersConnect member sessions, regional conferences and events, and other sponsor-hosted webinars or networking events.

Monthly member sessions offer discussions on the latest SBA lending updates with industry experts via an informal, interactive panel with the option to continue conversations beyond the session via our Newsfeed or speaker video office hours. Managers Exchange sessions are also held twice per month to share ideas, concerns, etc. related to management topics – these sessions will be limited to the first 50 due to the entirely face to face interactive format.






