One staff member has been a no call/no show numerous times and has now been warned that the next incident will terminate the employment. They are getting more transfer requests than they can handle. Many of the requests are coming from Traverse. QA/QI reviews discovered one med error. The purchase of radios for dispatch to the sheriff's office was approved for \$7360.
