- c. <u>Albert Township Tire Disposal:</u> On May 18th, Albert Township is offering tire disposal for \$1/tire.
- d. <u>Election Inspector Training</u>- A motion to send up to 6 people to training was made by Chinavare, 2nd by Rippee, motion carried unanimously.

- f. BS&A Tax Software- In addition to the start-up cost for this software, it will cost \$3935 annually.
