Sheriff Department: No representative present.

Landfill Report: Gary Girardin reporting. The lagoon is in. Injection well is not being used yet as it is not ready. Looking at June. CAT is bringing in a loader. The cost of hauling leachate reached \$121,936.14. Part-time employment is available.

County Road Commission: Chinavare reported that the roads will be brined with the county paying 50% again this year. Bruno Wojcik reporting. EGLE is not mandating rules for road brine. Hall Road bridge replacement is scheduled to begin on 5/01/23 funded by Huron Pines. There have been two road abandonment requests, one from Lewiston and one from Atlanta. Twin Lakes water quality is diminishing. They want the road commission to keep water from roads out of the lakes.

Fire Report: No representative present at Fire Board meeting.

Ambulance Report- Beau Williams reporting. Employees are leaving the company. Four left last month. There are only 29 employees remaining from a staff that was at fifty. The board has looked at raising wages \$4.00 per hour to compete in the marketplace. Jody believes a grant has come through for \$92000, but she is not positive. One van was paid off. One truck had a deer hit costing \$3800 and is down from it.
