Landfill Report: Reported by Gary Girardin. EGLE has extended the deadline to clean up debris in the area around the landfill. There is a problem with plastic bags blowing around all over the area. They are looking to hire a part time person to work on this problem. An accident at M-33 and M-65 resulted in 7 trains of contaminated ground taken to the landfill that will need to be tested. They want to drill and operate a disposal well for leachate and PFAS. Notice will be published in the Tribune.

County Road Commission: Reported by Bruno Wojcik. The road commission is very well run. Other counties are modeling after Montmorency. Todd Behring runs the department (Managing Director). Mike Walker is the Superintendent. Williams states that McIntire Road needs to be worked on. There are a lot of new full-time residents.

Fire Report: Reported by Donna Stehle. New uniforms were ordered. There was discussion on the millage.

Ambulance Report- Reported by Beau Williams. The millage was discussed. An extra mil will probably be pushed back. Ballot language is being looked at. The dedication to the education room will be to past employees instead of just the one employee. Ambulance costs are crazy!
