**Ambulance Report-** Beau Williams reporting. They were able to payback \$100,000 back to the general fund, as numbers are up. There will be another EMT class starting up. There has been a report of an employee miss-using an inhaler on their own time. There have been med reviews and inspections on the building. All have been favorable.
