They need 23 batteries and 12 chargers for the radios and approved to spend \$1000 for this. There will be a drive thru set up for Halloween. The annual meeting is on December 11, 2020. Loud Township will provide snacks.

- d. Designated Assessor-The costs submitted by the County Commissioners are horrible. The establishment would like to open on April 1, 2021. They are seeking a liquor license for 7 days per week and a package to go license. This is tabled, to be discussed in October.
