Ambulance Report: Beau Williams reporting. New Stryker cots and lifts will be purchased with a Grant from FEMA for \$306,000. The department will have to contribute \$15,000. Stryker wants to charge \$40,000 for maintenance for 7 years. Fleet report: #207 has a bad transmission. It will be used to harvest parts. The new remount will be in. The State will have to do an inspection. The Supervisor position has been filled by Al Lemcool. Debriefing was done for staff after a call
