Sheriff Department: No one in attendance.

Landfill Report: September 27: All customers are up to date with their bills. There are 2.4 million gallons available in the lagoons. There is a problem with L&M bringing in live rats that are being picked up at an Alpena school. October 11: The landfill is 5% higher in volume compared to last year. There are 3 new haulers out of Gaylord. The lagoons have room for 2.6 million gallons. There is consideration to dredge the lagoons for settlement. A new pump is needed for the evaporator. Great Lakes Tissue is bringing 200 yards per day of tissue with clay mixed in. This is plugging up the system. There is discussion to charge extra for special loads. PFAS are okay for now. NEMCOG is sending a representative to discuss the advantage of recycling.

County Road Commission: No one in attendance

Ambulance Report: Beau Williams reporting. The numbers were not good for the month. They had to pay for an ambulance. Payroll was a five pay month. An ambulance was allowed to go as scrap to an employee. The State inspected two ambulances. Everything was okay. There are

attitude problems with some of the personnel. Help wanted ads were placed in the paper for a Field Training Officer.

Fire Report- Elva Duncan reporting. The foundation is being dug for the sign out front. There were 70 runs, which is up from last year. Truck #213 is fixed and coming back to Loud Township. The annual meeting is on December 13, 2019. Briley is the host. The meeting will be at the Station.

Assessor-Cheryl Klein reporting. Inspections are 20% completed. The prior assessor did not complete sketches. They are being done now. A time sheet will be turned in for the additional hours. Mileage will also be turned in. Buildings have been found that were not previously recorded. Tax Tribunal: Riviera Resources filed a stipulation on Monday. They agreed to the same formula as all other municipals. It is quite a deduction. They are waiting for the Tax Tribunal to reply. They will get a refund for the summer, winter should be okay.

The ball court needs to be fixed. The Auxiliary will pay \$1000 and would like the Township to pay for the balance. The work will be done in the spring.
