

**WHAT DOES TRED AVON FAMILY WEALTH, LLC, DO WITH YOUR FINANCIAL INFORMATION?**

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and assets
- Transaction history
- Credit history and credit scores

**How?** All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information, the reasons Tred Avon Family Wealth, LLC, chooses to share, and whether you can limit this sharing.

This includes email, SMS, and any other form of communication.</p> <p><b>SMS opt-in or phone numbers for the purpose of SMS are not being shared.</b>  <i>By opting into SMS from a web form or other medium, you are agreeing to receive SMS messages from Tred Avon Family Wealth. This includes SMS messages for appointment scheduling, appointment reminders, post-visit instructions, and other general messages. Message frequency varies. Message and data rates may apply. **Definitions**

<b>Affiliates</b>	<p>Companies are related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>We may share information with our affiliates for our everyday business purposes, including information about your transactions and experiences.</i></li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>We do not share with nonaffiliates so that they can market to you.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>We do not jointly market.</i></li> </ul>
