

LANDMARK TO BE RAZED

Below: Goldcorp announced the impending demolition of the 103 year old building in November 2017. On September 18, 2018, it became apparent that demolition would soon commence, so John J. Fleming took some final photos of the building.



The Hollinger Mine Office Building, located on Algonquin Boulevard East at HWY 655, was constructed in 1915. One of the first all-brick buildings in the area, it served as the company headquarters until operations ceased in 1968. In its heyday, the property boasted lavish grounds including a water fountain and flower beds. In late 2017, Goldcorp (the current owner of the now vacant property) cited age, asbestos insulation, lack of accessibility options, and overall liability issues as justification for plans to demolish the historically significant building. Although the demolition process began in mid September, as of press time the building was still standing. While safety concerns are not to be taken lightly, the loss of a piece of our industrial heritage is disappointing to say the least.

am a lifetime resident of Schumacher with a 50-year history of volunteering. I'm particularly proud of personally raising over \$500,000 since 1994 to send over 2000 kids to Camp Bickell free of charge. I have a 43-year accounting background, mostly in senior positions, including 17 years on project accounting. Also, I have the experience of serving the last four years on council working in the best interest of Ward 3 and the taxpayers. In addition, I was appointed, and serve, on six boards, Timmins Economic Development, Audit Committee, Municipal Housing, Cochrane District Social Services, Municipal Accessibility and the Golden Manor Board of Management. No other candidate is as well prepared, to continue to represent Ward 3.

My name is Donna Dorrington and I believe that my education, work history and community involvement make me an ideal councillor for Ward 3. I have a degree in political science as well as a law degree. I am a lawyer, business owner, the Treasurer of the BIA, and a board member of Timmins Chamber of Commerce. I live with my husband and four of our children in Ward 3. Although I haven't lived my entire life here, I spent significant periods of my childhood enjoying the neighbourhoods when I would visit my family for summer and holiday periods. I have very fond memories of attending church services with Father Costello, walking the friendly streets and attending many sporting activities at the McIntyre Arena which I continue to do today.

was born and raised in Schumacher and fully intend on staying here. My parents owned a small family business for over 40 yrs. I attended Schumacher Public, Roland Michener, Timmins High. Centennial College and Northern College in Mechanical Trades. My career started at the McIntyre, then a technician for the largest equipment dealership, to Interim Branch Manager, Project Manager. I assisted with the start up of Dome Pit. DeBeers. Detour Lake. Baker Lake NT, and then a Maintenance Superintendent. I've spent the last 6 years teaching at Northern College part time in the Automotive Heavy Equipment Trades. My greatest community connection is volunteering with the Schumacher Fire Department for the last 14 years and piloting Young Eagles.

Please describe your election platform as it relates to goals and priorities in both Ward 3 and the greater City of Timmins.

The first goal of the new council will be to get it's priorities in order by reducing non-essential spending. We should not be losing millions, of taxpayers dollars, in the concert business and planning a \$48M aquatics center, that will add to the city's near \$100M debt load, including interest. Debt is debt no matter where the city finds money to service it. The money is unavailable to do other projects. There should be zero non-essential spending until we fix the condition of our roads, stop sewage from entering Porcupine Lake, address a shortage of affordable housing, find money to extend fire protection, work with TPS for additional presence and foot patrols and fix our crumbling infrastructure.

I will create a Community Plan that will focus on: safety; economic viability and quality of life for the residents of Ward 3 and Timmins. Part of that plan will be to advocate for increased police presence, fire hydrants/water supply for all housing, clean roads and sidewalks free of debris and snow. Economic viability can be achieved through arts and culture and the creation of affordable housing. I will advocate to re-purpose buildings to bring in markets, vendors, artists, new tenants etc. and I will seek to beautify the neighbourhoods. To show my commitment to this, I will donate my honourium to a fund to assist with these projects. I will hold monthly meetings to discuss the Community Plan to ensure our shared goals are met.

Better policing; Volunteer Fire Departments; Garbage pick-up; Local speed limit; Heavy traffic; Additional stop signs; Youth groups; Homeless assistance; Road maintenance: Regenerate McIntyre Park; Elderly transit assistance; Abandoned derelict homes; Bus service extended; Youth skills programs; Business incentives; Walking trails; Outdoor rinks; Public use of arenas; Need new Aquatic Centre?; Need project consultants?: Surveillance cameras; Community meetings; Noise and dust issues; Parking restrictions; McIntyre Arena Repair: Boundary Lane: Municipal Porcupine manpower: Lake: Pearl Lake Cultural gardens; Green operators; Accountability; Police, Transparency; responders, military recognition.

A significant concern in Ward 3 stems from issues related to absentee owners and abandoned/derelict buildings. What is your plan to address this issue?

I would like to see an incentive program developed to encourage landlords to turn these properties from liabilities back into assets. In the case of residential, if it was a single family dwelling before, can we make it a single family dwelling again. In the case of commercial, can we revitalize and repurpose some of these buildings to productive use. If demolishing is the alternative, we have to look at the timeframe it takes under the current bylaw to demolish these buildings. The current bylaw covers most situations dealing with absentee owners and derelict/ abandoned buildings. However, we need to revise the bylaw to provide the tools to expedite the process leading to demolishing and we need to increase the penalties for non-compliance.

Abandoned and derelict buildings is a very important issue that needs immediate attention. I will work with the community to develop an Abandoned/Derelict Property Strategy that will focus on 1) Preventing Abandonment, ie. incentives, loan programs etc 2) Gaining Control of Abandoned Properties, ie. by-law enforcement, tax foreclosure etc and 3) Fostering Re-Use of Abandoned Properties, ie. establishing a youth or community centre, creation of an indoor community garden etc. I understand that this issue is one of great importance that involves the intersection of safety and pride in community. I will work with the community and the appropriate stakeholders authorities and to ensure that we establish a reasonable and achievable plan.

Derelict buildings are a concern to all of the City. We need to introduce by-laws that follow local and provincial regulations. It needs to be a transition that is fair and legal. Bad homes and properties need to be addressed to make them safe to the neighborhood and pedestrians. This is a concern to property owners that have a relatively high tax rate with severely reduced property values. A by-law is needed that allows access to evaluate, address and notify the owner of required repairs. We need to be fair and accommodating with this notice. The notice could possibly be 3 warnings over 3 months, then a 3 to 6 month action date to a final 30 day notice and if not acted on, the final result to demolish or sell.

What is your position regarding the preservation of historical buildings such as the McIntyre Headframe, McIntyre Community Building, and Schumacher Public School?

I feel very strongly that we must do whatever is necessary to preserve our historical buildings city wide. I am a member of a Schumacher revitalization committee that can, and will, continue to take a role in this process. Personally, I have already taken a major step towards revitalization by spearheading the development of a preliminary concept study to revitalize the McIntyre Community Building into a year-round event center. Seating capacity would be increased to 4.200. The design involved raising the roof, adding corporate boxes, new washrooms, new dressing rooms, concession stands and 14,000 new square feet of exhibit space. This is a major step in preserving the Mac. The refined presentation will come back to council in 2019.

Preservation and restoration of old buildings is important to all cities. While innovation in building and creating "new" structures is necessary in any city's natural progression, maintaining preserving the old monuments is critical because buildings such the McIntyre Headframe, Community McIntyre Building and Schumacher Public School are reflections of Ward 3's vibrant history. These buildings along with others help people to understand and respect the eras before us and their unique traditions and what they stood for. These buildings are part of the city's fabric and energy and need to remain so.

Explain why it is the right time for Ward 3 residents to elect you as their council representative.

Over the next term of office. Ward 3 and the city will be facing numerous challenges both financially and socially. It is extremely important that you have the right experienced people who are at the council table for the right reasons. You have that person and I have proven it over the past four years by working tirelessly to represent you and to not betray your trust. Regardless of the request from a resident, big or small, I tried to resolve it and in most cases I was successful. There is plenty of opportunity for savings. and tax relief, with the right council. Having my experience of sitting on council and six city boards and understanding the process gives voters the best opportunity to realize these savings.

This election isn't about me or any other candidate. It is about what sort of future you want for this community and Timmins as a whole. Ward 3 is a great community but we can't take that for granted. I believe I will bring a renewed energy and new ideas to the community. I am committed to creating a constructive Community Plan and to meet with residents to focus on their genuine concerns and goals. Being a progressive Councillor isn't just about attending Council Meetings. What happens in the time between those meetings is what really matters to people.

It's time for change. Our community

has been dwindling for years.

Regardless if you were here for

decades or just moved in recently,



Please briefly introduce yourself by outlining your background, relevant qualities / experience, and your connections to the communities within Timmins.

I am a proud resident of Ward 3. I am the only candidate whom has municipal experience. With 8 years on city council (4 of those years as Mayor) I bring municipal experience to the table that no other candidate can offer. I am Chair of the Timmins Police Service Board, Chair of the Cochrane District Social Services Board (responsible for EMS, housing, childcare, and Ontario Works programs), Chair of the Timmins Violence Against Women Advisory Committee, Vice-Chair of the Timmins Economic Development Corporation, Board Member of the Porcupine Health Unit, Board Member of the Timmins and District Hospital, Board Member of the Mattagami Region Conservation Authority, and Board Member of the Federation of Northern Ontario Municipalities.

Timmins has been my home since birth. My interest in the trades began after I graduated from Theriault High in a four year technology stream. I completed a five year apprenticeship with a Diploma in electrical field as an underground electrician at Kidd Creek mine. Later I started my own electrical business in Timmins. I relocated in Southern Ontario, I became a Member of Local 303 and was elected on the executive board. I bring new insight that will benefit this City. I know what this city needs and how to implement the necessary changes.

Some ask, Do I have politic back ground? Well, was Arnold Schwarzenegger a politician when he became mayor? Life is all about politics! it all depends what road you decide to take, how much money do you make? Who you know and rub elbows with? Your Work, the language you speak and the color of your skin. If you don't fit in, then your cast away. But what I've learned is never complain and do something about it. I look back on my life of all the things I have done and accomplish. I wish I had more space and time to explain why I'm a good candidate for this job. Most of my life, I lived in many different area of Timmins, Schumacher, Mountjoy. I experience from being poor to average, this made me the man I am today, fighting to survive.

Please describe your election platform as it relates to goals and priorities in both Ward 3 and the greater City of Timmins.

My platform focus is on 4 pillars including: 1) Jobs and the Economy, 2) Quality of Life, 3) Infrastructure, 4) Affordability and Access to Services. I believe these are common goals for all residents. Portions of that platform that I feel would be of particular interest to Ward 3 residents would include the continued work on the Noront bid to ensure Timmins sees the Ferrochrome Processing facility and the 300 jobs that come with it. My platform will include enhanced seniors tax rebate programs and reduced seniors monthly transit passes. I will also support enhanced Timmins Police patrols in residential neighbourhoods and an enhanced residential roads program along with continued work along the connecting link highway.

A vote for Ray Burey is a vote for a Ring road "Porcupine Trail"

A vote for me is a vote for a smart city located in the down town core. Once the down town core has been taken care of we will replicate and expand the Smart City to the other wards and rejuvenate all wards in our community. Ward three is in dire need of up grads. I will ask the locals of ward three to form a committee to find out what ward three citizen want to improve in their area.

A vote for me is a vote to lower taxes to provincial levels of 1% of appraisal of your property value. Find new forms of taxation that does not crush the middle class. A rebait for the elderly and people on fix incomes. These rebaits will be cap at 9% of their house hold income.

My platform is the 3 Pillars of Sustainability, Meeting the needs of the present without compromising the ability of future generations to meet theirs. It has three main pillars: economic, environmental, social. Some residence don't know what ward 3 also included? Golden center, Buffalo Ankrite, and Delnite. Some seems that they are neglected in some services and pay also high taxes. As I explore more into Delnite, they do have fire hydrants on site but out of service. The fire dept. must shuttle water from McDonald lake to Delnite property. Where is the cost saving? Someone life and home or using fuel back and forth and take a chance the woods will not burn also. This will be seriously look at to get this done.

A significant concern in Ward 3 stems from issues related to absentee owners and abandoned/derelict buildings. What is your plan to address this issue?

I believe this concern could be addressed through the expansion of our CIP program that exists Timmins downtown Schumacher. This would provide incentives to redevelop these buildings. I believe partnering with the arts and culture community could bring new life to some of these buildings. While visiting our sister city in Naoshima Japan I witnessed what a small community could do by creating a strategy focused on arts and culture and the use of abandoned buildings. That community of under 4000 people sees 100,000s of people come every year to see the community art exhibits and museums. This took large private sector investment but could be done on a smaller scale within Ward 3 with the support of progressive council members.

As a City we will have to seize these properties, as a former resident of ward three one of my biggest concern was the lack of parking. Houses are cramp in certain area of ward three. I would convert those seized properties and convert some into municipal run parking space and when possible create some green space. The revenue of the parking lots would offset the cost of demolition.

How will I help "ward 3". Listen to the people and Councillors. I myself will be going out to different wards if elected and talk with people, not always be in the office. If we can, any Small business that want to open new doors, we can wave the licensing fee for a year and maybe look into grants from the city. Councillors, also known as Members of Council, play both a legislative role and a constituency role. Typical Councillors workload includes. Chair or member of a standing committee, Chair or member of a community council. Chair or member of additional committees and boards such as sub-committees. They are your voice!

What is your position regarding the preservation of historical buildings such as the McIntyre Headframe, McIntyre Community Building, and Schumacher Public School?

The McIntyre Headframe is not just an iconic symbol of Ward 3 but the entire city. I am committed to ensuring this icon is seen as people enter Timmins for generations to come. The McIntyre Community Building is the only building in our city that is large enough to host junior hockey, conferences and large scale events. Even if the new multi-use recreation facility is built the Mac will remain the only facility capable of this. It is important to ensure future generations can continue to benefit from the facility as generations before have. Schumacher Public school is a critical facility in ward 3 and we must continue to make partnerships to ensure it remains in use in Ward 3. The ability to attract new families to Ward 3 requires it.

Ward three people are a proud and hard working lot. I see no problem keeping these building relevant. Come with a good plan and I will support you in making your community all that it can be. I remember when Schumacher was vibrant, going to the post office toke an hour, people were all so friendly. My wife and I have great memories of living in our little apartment on second avenue.

Explain why it is the right time for Ward 3 residents to elect you as Mayor of the City of Timmins.

The City of Timmins has been shy to invest in itself and the quality of life residents enjoy for many years. We have begun to move forward and accept our residents deserve better. We deserve better roads. water, and sewer infrastructure in all areas of the city. Please briefly introduce yourself by outlining your background, relevant qualities / experience, and your connections to the communities within Timmins.

I was born in Timmins a little over 26 years ago and Timmins has been my home for the vast majority of the time since then. The only time I have live anywhere else was when I went to Ottawa for university. There I earned a BA in history while at the same time I began to take an interest in politics. At the same time I was working in the construction industry to fund my way through university. As a result of these two disparate I have a strong appreciation for hard work in all it's forms.

Please describe your election platform as it relates to goals and priorities in both Ward 3 and the greater City of Timmins.

Ward 3. as with the rest of the city. is going to need major infrastructure improvements in the coming years and I believe the city should be making bigger investments in this area. But more than that, I would see the city put more focus on cleaning and maintaining our streets and city properties. As an example, the time of me writing this there has been an old boot sitting at the side of the highway for 3 months by the McIntyre Community Centre. This as well as dirt and rocks strewn across the streets and highways shows the city isn't cleaning properly. This upsets residents of our city and makes the city look bad to visitors and it cannot continue.

While the existence of absentee owners is unfortunate, it can be tolerated as long as they maintain their properties. Derelict buildings however, become eyesores but they also devalue neighboring properties. These properties have a negative effect on the city's image to both residents and visitors. They also worsens our prospects of having people move to our city or of having business expand here. As I indicated in my previously we need to take step to clean up the city and this is one area that the city can take action. To combat this issue the city needs to more aggressively enforce existing bylaws and if need be, enact new ones with harsher punishments for allowing a building to remain derelict.

There are by-laws in place that address this issue. At least one of our past mayor's, Tom Laughrin made it a priority that the by-laws be enforced. I will do the same. Additionally I will work with the residents and city administration to address any deficiencies with the bylaws if required, to address these concerns.


