CALL TO ORDER (Chair – John Heinegg)

President John Heinegg chairing. HICEEC AGM called to order at 3:05 p.m.

INTRODUCTION OF BOARD, STAFF & COMMITTEES (Chair – John Heinegg)

Each board member and staff. John Heinegg welcomed everyone, and acknowledged First Nations Territory.

ESTABLISHMENT OF QUORUM (Secretary – Katherine Ronan) 10% of membership/141 members 28 Participants. 20 members, 7 Board, 1 staff. Quorum is met.

REPORTS

I. Minutes of the 2021 AGM (Karen Ross)

Minutes were read aloud by Karen Ross and approved as presented by general agreement (poll) - 3 abstained, remainder in approval.

II. Chair Report (John Heinegg)

Received. Presented by John Heinegg. Reviewed the monthly First Edition articles and found 10 main items reported on. Focus on the 4 top areas being addressed:

- High Speed Internet John Grayson and Karen Ross worked for about 5 years on this state of the art, benefitting many generations to come – health care, education, economy, remote workers, etc. Note: The Nov/21 referendum on Hornby and Denman Islands, for the CVRD to fund part of the project passed by an incredible 93%.
- 2. Food Security John Grayson is on both the Farmland Trust and the HICEEC Boards. Announcing the CERIP grant, worked on by FFT (Gary Manzer, Una Keziere, John Grayson) and HICEEC (Peter Wardle, Katherine Ronan, Karen Ross), resulted in \$678,000. For a food processing hub, to complete construction within18 months. Katherine and Peter continue to participate in revamping the design to reflect increased costs of construction. There will be an information meeting on June 8th, for input from the farmers/growers/food providers to provide feedback on what they want to see.

- 3. Messaging Redo on the hornbyisland.com website, which was glitching. Board members Jeff Zamluk and Carlyn Bishop, with managing partner Jake Berman, and staff Karen Ross guided a redevelopment of the site. HICEEC ended up buying Jake out of his 50% ownership, and Jeff quit when the project was delayed. Thanks to Carlyn and Karen for seeing it through to the being usable. Carlyn reports great traffic,website working well, and # 1 opening (non paid) page (Search Engine Optimization).
- 4. Housing Focus on workforce housing. Katherine is the Board Lead, Donna is working with her. Basically suggesting a manufactured home park, with rental pads.
- 5. Grants
 - a. 2021 total \$3750., \$1750. To Water Stewardship; \$2000. To Farmers Market.
 - b. Total grants to date, 2012 to 2021 = \$90,121.

1. BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the balance sheet of Hornby Island Community Economic Enhancement Corporation as at December 31, 2021 and the statement of operations and change in net assets for the year then ended is on the historical cost basis, reflecting cash transactions with the addition of:

- (a) Accounts receivable
- (b) Investments recorded at cost
- (c) Property and equipment amortized over their useful life
 (d) Accounts payable and accrued liabilities
- (e) Deferred contributions and revenue recorded on an accrual basis

M/S/C Donna Tuele/Carlyn Bishop to approve the financials. 4 abstained, remainder in favour

M/S/C Jack Hornstein/Katherine Ronan Appointment of accountants: Motion to appoint Tara Smith, of Courtenay, to complete a Notice to Readers accounting for the 2022 fiscal year. "That Tara Smith of Courtenay be appointed to complete a Notice to Readers for the 2022 Fiscal year to be presented at the 2023 AGM." Vote: 4 abstained, remainder in favour

M/S/C Carlyn Bishop/Katherine Ronan "Waive requirement for an audit in favour of the Notice to Readers, due to financial costs. 3 types of financial oversight: "Notice to Reader", approx. cost \$1800., "Review Engagement", approx. cost \$5000., "Audit" approx. cost \$10,000. Vote: 4 opposed, 1 abstained, remainder in favour

To: "Meetings of members may be held in part, or entirely, by telephonic, an eletronoic or other communication facility. Moved by John Grayson, Seconded by Donna Tuele. Question: if there was Zoom and in-person, how would a quorum be determined? Answer: 10% of total attendance

Motion Carried.

27. Appointed Directors

In addition to the Directors elected at an Annual Meeting, the Hornby Island Residents & Ratepayers Association shall appoint two (2) directors. All the provisions of the Articles

and Bylaws of the Corporation shall apply to the Appointed Directors including that Appointed Directors shall be entitiled to vote.....

To: In addition to the Directors elected at an Annual Meeting, the Hornby Island Residents & Ratepayers Association may appoint up to two (2) directors, who will subject to the same approval process as Members, under Section 9 of these Bylaws...

Moved by Katherine Ronan, Seconded by John Grayson Heated debate ensued.

Board member Rudy Rogalsky spoke against this Bylaw change

HIRRA president Daniel Siegel expressed his dissatisfaction that HIRRA was not consulted on a bylaw that impacted his organization. He stated that he had another nominee for the unfilled position that HIRRA was to appoint.

John Heinegg commented that the discussions regarding this amendment have taken place for over 2 months at the Board level, and the HIRRA appointee was included in those discussions.

Rudy made an additional motion. More heated discussion as to how to apply Roberts Rules of Order.

Chair Heinegg ruled that the discussion would proceed on the first motion, settle that and then discuss Rudy's motion to quash the Board motion.

Mary McKenzie read a letter from Jan Kennedy speaking against the amendment Wendy Burton "called the question", and further discussion was stopped The motion was presented to the floor, and defeated.

Katherine Ronan thanked people for their feedback and was encouraging about input going into the future.

The proposed bylaw amendment to Section 27: Appointed Directors will not proceed.

NOMINATION AND ELECTION OF DIRECTORS (Chair – John Heinegg, Secretary – Katherine Ronan) As HICEEC seeks to recruit Directors with particular skills, nominations must be pre-approved. Nominations from the floor require the support of 5% of members present.

Katherine Ronan's term is up and she is standing for re-election. No nominations from the floor

M/S/C John Grayson/Carlyn Bishop "That the nominations of Katherine Ronan to the Board of Directors be approved."
