The rules language states that "professionals and elite amateurs will no longer be allowed to use a driver in excess of 46 inches-the current limit is **48 inches**-at events that choose to implement the rule."

**Handicap Committee:** Once again, a reminder to post your score within 24 hours after completion of your round. It is highly encouraged to post your score using the hole-by-hole method in order to receive the applicable adjustments.

**Classic Points:** Members are reminded that 60 points and attendance at two monthly meetings as a minimum are required to participate in the Annual Classic Tournament. A maximum of 30 points are allowed from meeting attendance.
