**Rules Committee:** Once again, we have been reminded that many of our members are not aware of some of the important rules of golf. Please reach out to those fellow members who have an excellent understanding of the important rules.

**Classic Points:** Classic point collection ends on December 31st. Members are given the option of playing in either the January 6th event (Thursday) or the January 8th event (Saturday). Members can play in both events however only one event can be selected for their Classic participation. Deadline to sign up is Jan 3rd. Skins and "KP's" are available for both events for \$15.

**Other Business:** A motion was introduced to allow members who do not have the minimum required Classic points to purchase the required points for \$2 each. This would allow those members to participate in the event. The motion was discussed and subsequently voted down.

**Monthly Meetings Issue:** Vice President Kasch introduced a motion that beginning in 2022, monthly membership meetings will now be held on a quarterly basis. This motion was approved. Meetings will be aligned with Tournament events and members will receive 15 Classic points for meeting attendance. Once again, maximum meeting points will remain capped at 30 points. There will be no evening meetings!

The 2022 schedule will be posted in January.
