Cares Act, EIDL, PPP.

Yeah, let's talk about PPP. Does anything about this make much sense? Apparently not, as the rules changed almost as often as one changes clothes. New terms were created for the program. Definitions of old terms changed for the program. It's a loan, it's a grant, 8 weeks, 24 weeks, 2 year payback, 5 year payback, it's not taxable, it is taxable, where does it stop?

Obviously, this program was one that was rushed to be put into place. Necessary or not, you can decide. Fact is, it was rushed out without fully considering all aspects of the program. The continuous changes are evidence of that. After all the uncertainty of the program for months, the IRS decided they wanted to help create even more uncertainty by issuing their interpretation which, just so happened to be a complete contradiction to the original intent of those who wrote the Cares Act.

As if that wasn't enough, the IRS then issued Rev Rul 2020-27 and Rev Proc 2020-51 (attached) to double down on their position. The issuance of the Rev Rul and Rev Proc left me scratching my head. I understand and appreciate releasing guidance as soon as possible, but why would the IRS issue such guidance when it appears Congress may try to clarify their original intent. In addition, this guidance seems to me to contradict the rules of income recognition for taxpayers using the cash method of accounting.

What a strange year this has been.
