## **WEAPONS**

- > Drugs, alcohol, or paraphernalia, to include K2 or bath salts.
- Narcotics or mood-altering substances, drug paraphernalia, drugs or intoxicants not prescribed for the individual by medical staff.

## **MONEY**

- No more than \$60.00 cash.
- Counterfeit, forged or otherwise unauthorized reproduction of money.

## **MEDICATIONS**

- Unauthorized medications of any kind.
- ➤ Illicit drugs (including alcohol).
- Medications, including over-the-counter, vitamins, nutritional powders, etc.
- All medications, from any source, must be maintained in the medication room.

## **ELECTRONICS**

- > Televisions.
- Radios.
- > Tape players.
- Recorders.
- > Cameras.
- VCRs or cassettes.
- DVD players or DVDs.
- ➤ MP3 players.
- Electronic tablets.
- Apple products.
- Laptops.
- Electronic games or electronic gaming equipment.
- Headphones/ear buds.
- Cellphones.
- > Smart watches.
- > Electrical appliances.

## ABODE TREATMENT, INC. THE FOLLOWING ITEMS ARE PROHIBITED ON FACILITY PROPERTY

#### **CLOTHING / JEWELRY**

- Clothes which exhibit sexually explicit or suggestive images, statements, or themes which promote or are suggestive of violence, drug/alcohol use, or display drug and/or alcohol symbols; include any ethnic slurs, or in any way are degrading to self or others; reference the exploitation of others; reference discrimination; promote anarchy; display satanic words or symbols; display words or images associated with gangs; display obscene words or images; and/or any other questionable contents as defined by ABODE Treatment, Inc. personnel.
- Tank tops, muscle shirts, or sleeveless shirts.
- > Sleeveless shirts or clothing with slashes or cuts.
- Tight-fitting clothing.
- Articles bearing holes in seat, crotch, legs, etc.
- > Sunglasses.
- > Expensive items.
- Expensive jewelry or flamboyantly worn or displayed jewelry.
- Sagging pants.
- > Spikes/cleats, etc.
- More than seven (7) total changes of clothes.
- More than three (3) total pairs of shoes.
- More than seven (7) clothes hangers (plastic only).
- Hats with the exception of a Kufi. Clients of the Muslim faith are permitted to wear a Kufi inside the facility only if the:
  - Case file material received from TDCJ, applicable Community Supervision & Corrections Department, sentencing court, or SAFPF unit confirms the client's religion is Muslim; and the
  - Kufi is white or cream in color.

#### **OTHER**

- Literature, etc. which contain or exhibit sexually explicit materials, or themes which promote violence, drug/alcohol use, exploitation of others, discrimination, anarchy, and/or other questionable contents as defined by ABODE Treatment, Inc. personnel.
- Clients are discouraged from bringing in highly expensive/valuable personal items that could be lost or stolen.
- Products with toxic substances (i.e., glue, bleach, etc.).
- ➤ All personal belongings and/or valuables which require "special" storage.
- Teeth grills.
- > Tattoo equipment.
- Counterfeit, forged or unauthorized reproduction of any document, article of identification, security, check stubs or official paper.
- > Gambling materials.
- Backpacks.
- Luggage.
- Bags or containers of any kind that are not mesh or transparent.
- Cologne.
- Aerosol spray.
- Mouthwash or any product containing alcohol.
- Unapproved vehicles.
- Extension cords.
- Potpourri, incense or candles.
- Wire hangers.
- Hair clippers.
- Baby powder.
- Foot powder.
- Powdered laundry detergent.
