### General conditions for Gift Vouchers

- These general conditions are applicable for use by gift vouchers from Mark McDonnell – Applied Biomagnetic Therapy.

- Those conditions are applicable from the moment of buying a gift voucher until the value of the voucher is completely used up or the validity timeframe has been reached.
- We maintain the rights to modify the listed conditions when this is deemed necessary. We will of course have those conditions available on our website for review when necessary, [www.markmcdonnell.nl](http://www.markmcdonnell.nl)
- You have the right after purchasing a gift voucher to cancel it within 14 days. Please contact us to validate this request and we will return your money.
- The gift voucher is valid in exchange of therapy sessions by Mark McDonnell – Applied Biomagnetic Therapy. It is not valid in exchange for other gift vouchers.
- The value of the gift voucher will be taken from the total cost of one therapy session, after the unique voucher code has been verified.
- Mark McDonnell – Applied Biomagnetic Therapy reserves the right to refuse the gift voucher if it is deemed to be fraudulent due to damage or where changes have been made. This also applies if the voucher is deemed to be received by the user in a fraudulent way.
- The gift voucher is to be used only once and any amount left over will be no longer valid.
- It is not possible to receive cash money or any other form of money in exchange for a voucher.
- The gift voucher is valid for one year after purchase. At the end of this term the voucher cannot be extended, exchanged, reclaimed. The value will then be cancelled. You will also not receive a reminder that the validity period is coming to an end. It is therefore your responsibility to ensure the value is completely used up within the validity period.
- Mark McDonnell Applied Biomagnetic Therapy is not responsible and no claims can be made against him in the event that the voucher is stolen or damaged. The risk is transferred to the buyer at the moment of purchase.
