CA Voter ID Initiative

Carl DeMaio joined us in our July meetings and spoke to us about the initiative.



This has been authored as a state constitutional amendment such that it will, when approved, impose the Voter ID requirement for all future elections in California. The amendment has three basis requirements:

1) Photo ID to vote.

A voter will need to provide a government issued ID for in-person voting. If voting by mail, the last four digits of the matching driver's license must be provided. This will

allow election officials to verify the voter identity.

2) Accurate voter lists.

Election officials will be required to maintain accurate voter rolls, and remove all ineligible voters before ballots are mailed out.

3) Verification of citizenship.

Election officials will be required to verify the citizenship of an individual before adding the individual to the state's voter rolls.

So, how can YOU help?

<u>First</u>, you can sign the online petition at <u>www.voterIDpetition.org</u>.

Second, consider being a volunteer to get signatures from friends, family, and your neighbors. Use the link www.voterIDvolunteer.org to speak up and tell them you want to collect signatures. Anything more than your signature is a step in the right direction.

Third, consider contributing to the campaign. You can use www.voterIDinitiative.org to access the secure online donation portal.
