**INFORMATION:**

On 02/27/2016, I (PSO Cote) and PSO Herrmann were dispatched to listed address for a reported domestic. Upon arrival, the scene was found to be calm and the parties all separated. The male half, listed Edward [REDACTED], was in the bedroom with his mother who had been placed on hospice and the female half, listed Peggy [REDACTED], was in the living room. Edwards was said to have pulled his sisters arm to get her out of the way so he could see his dying mother. There



were no physical marks on Peggy's arm and she stated that she was alright. It was said numerous times that the seven siblings do not get along.

#### **INTERVIEW WITH PEGGY [REDACTED]**

Peggy stated that Edwards has not seen his mother in almost four months. Upon learning that his mother had been placed in hospice, Edwards arrived at the residence and waited for hospice workers to arrive on scene. Peggy stated that she had approached Edwards once he entered the residence and attempted to tell him what was happening with their mother. Edwards became angry with her and when he was attempting to enter their mothers room, grabbed her arm and pulled her out of the way. Peggy then called police.

#### **INTERVIEW WITH EDWARD [REDACTED]**

Edward stated that his sisters do not allow him to see his mother. Edward stated that he learned his mother was on hospice and wanted to see her. Edward waited for hospice workers to arrive and walked inside the residence with them because he knew his sisters would not like him being there. Edwards stated that upon him entering the residence and attempting to see his dying mother, listed Peggy got in front of him and began telling him what he was allowed to do.

#### **OUTCOME:**

Edwards was allowed to see his mother for some time. Peggy was not injured in any way and there were no injuries visible to prove otherwise. Edwards asked to collect some picture frames from the house and the items were collected by Peggy, they were then given to Edward. Edward left the scene with no further issues. Everyone at the residence was calm and just wanted their mother to be at peace.
