The Chairman reported that there was very little to give an update on, however he is doing some work on the possibilities of Training Endorsement. The Gen Sec also added that he was working on running a couple of Zoom based CPD webinars.

- There was some discussion about the Fire Statistics and what the BFSA can do to promote fire safety. The Gen Sec has looked at the available data and it seems that the most we can do is to highlight various underlying causes of fires and possible growing trends using our Social Media & Website.
