1. we reserve the right to select vendors based on product quality and/or to ensure we have a sustainable balance of products. preference will be given to returning vendors, local artisans or crafters who personally manufacture their products or produce the raw materials that go in to them.
2. Product prices should be retail for-profit prices
3. Fees are due when the application is accepted. Tables will be assigned as fees are received. refunds for cancellations will be provided at the Society's sole discretion.
4. Vendors may set up Friday between 12:00 - 3:00 PM, and Saturday morning between 8:30 am and 9:00 am.
5. All vendors must remain in place until 3:00 PM and agree not to pack up/remove good prior to that time
6. Vendors must unload there vehicle and then immediately remove it from prime parking / unload area adjacent to the buildings to allow other vendors (and later costumers) access. all vehicles must be moved by 8:45 AM. pleas use the North Entrance doors as it is the closest access point to the hall.
7. Extra stock must be kept tidy and out of sight when possible. products and displays must not overflow into the aisles so as to obstruct the flow of traffic or another vendors space. Tables and painted walls must not be damaged (there is to be nothing attached to the walls).
8. Food Vendors must fallow the Temporary Food Markets Guideline for the Sale of Foods at Temporary Markets including any instructions from Fraser Health Authority. High-risk food products (e.g. dairy, eggs, meat ect.) are STRICTLY NOT ALLOWED under any circumstances. All food must be properly packaged for sale and not for immediate consumption
9. Clearbrook Golden Age Society will not be responsible for loss, damage or injury.
10. All participants must be properly clothed and conduct themselves appropriately while serving the public.
