### TERMS & CONDITIONS / TERMINOS Y CONDICIONES

I understand that I am responsible for any tuition and fees not covered by my scholarship. I agree to the terms of this agreement between the administration and myself. **\_\_\_\_\_ (initials)**

In the event that I withdraw my child at any time during the current academic year, I agree to pay the one-time registration, books, testing fee whether waived or not paid in full at registration or if the fees are not covered by the scholarship. In addition, an early withdraw fee of \$500.00 per student will apply. **\_\_\_\_\_ (initials)**

### STUDENT FINANCIAL SUSPENSION POLICY / POLÍTICA DE SUSPENSION FINANCIERA

Any student's tuition overdue beyond the 5<sup>th</sup> of the month following the current month is cause for suspension until the entire bill is paid in full. (For example: if the January bill is not paid, it is delinquent on the 6<sup>th</sup> of January; if it is not paid by February 5<sup>th</sup>, the student will be suspended on February 6<sup>th</sup> until both months are paid in full including all late charges.) **\_\_\_\_\_ (initials)**

Any student who arrives on campus before 8:00am unless agreed in writing by principal/administrator or who remains on campus before 8:00am or after 2:30pm other than for sports or extracurricular activities shall be subject to extended care fees. Should a student remain on campus for sports or extracurricular activities, they are required to leave the campus immediately after dismissal from the activity. **\_\_\_\_\_ (initials)**
