The Public Hearing is for the purpose of hearing comments regarding
the application for a Special Use Permit permitting a Solar Park in
Turner Township submitted by DTE Electric Company.

The proposed project is a large-scale solar energy project projected to
include approximately 120 megawatts of photovoltaic panels located
across sections 19, 20, 28, 29, and 30 of Turner Township. The total
site size is approximately 1,421 acres with panels occupying
approximately 582 acres. The project will be located across multiple
