**COMMITMENT &
TERMS OF
REFERENCE**
**Board of Advisors, Colleagues,
Partners, Ambassadors, & Trustees**

These terms of reference are intended to govern the relationship between The US Presidential Service Center (USPSC), US Presidential Culinary Museum (USPCM), as managed by Mongiello Holdings, LLC (MH), marketed by Mongiello Associates Strategic Marketing Firm (MA) and housed physically within its host of The Inn of the Patriots, LLC (TIOTP) and individuals whom we seek to honor and incentivize to further the interests of the museum and foundation. The collective entities mentioned of USPSC, USPCM, MH, MA, and TIOTP are collectively known as being staffed by our military veteran's disabled project and called VETS. The spirit of this relationship is intended to be one of mutual respect, support, collaboration, and enjoyment.

VETS and you agree to the following:

1. The individual shall represent themselves, their company, or their country to the United States Presidential Service Center (USPSC) and United States Presidential Culinary Museum (USPCM). They are not an employee or licensed actor on behalf of the USPSC;
2. The individual is expected to act in the best interests of the USPSC and USPCM:
 - 2.1. general responsibilities include, but are not limited to, being available for media interviews from time to time, promoting USPSC and USPCM initiatives through his/her personal networks, and inviting appropriate organizations, government departments, and individuals to participate in USPSC and USPCM initiatives.
 - 2.2. The individual will promote USPSC and USPCM activities and develop relationships with the following institutions in his/her own area at his/her best extent:
 - 2.2.1. Museums and like-minded foundations
 - 2.2.2. Travel enthusiasts
 - 2.2.3. Chambers of Commerce and Industry
 - 2.2.4. The media, bloggers, foodies, armchair historians
 - 2.2.5. Writers and storytellers
 - 2.2.6. Innovation Centers/Parks
 - 2.2.7. Incubation Centers
 - 2.2.8. Acceleration Centers
 - 2.2.9. Banks
 - 2.2.10. Crowdfunding Platforms and VC's
 - 2.2.11. Veterans groups and those associations that need help
 - 2.2.12. NGOs like Our Daily Bread with Kim Alexander

3. Other than the remuneration explicitly outlined in this agreement, VETS does not provide fixed pay or cover any costs incurred by the individual.
4. It is the individuals prerogative to decide the time they will dedicate to this role;
5. VETS will provide a PDF from which to print their business cards and promotional material in PDF format.
6. VETS guarantees a special discounted rate or free entry to attend the leading annual event and any other events where there is mutual agreement to do so. We provide complimentary meals and room nights as well, at times, at The Inn of the Patriots, LLC.
7. The individual will please accept that he or she is not working for VETS. ON many ad hoc occasions we will hire and pay as an independent contractor for temporary achievement of goals and work defined beforehand, and agreed to via price and work to be completed, in writing. In some cases we will send work to you via high-recommendation to a client or deal flow.
8. The Individual guarantees their attendance and support for online events only or to at least support such after that on social media when a guest speaker is hosted, or an event is conducted.
9. VETS and the individual may, from time to time, make amendments to this agreement provided both parties agree to the amendments via e-mail.
10. Basic expectations of VETS and the individual have already been defined before signing this agreement. They are much like being on any museum or foundation board;
11. The VETS and individual can share in selected financial responsibility offerings or items for any activity mutually beneficial to the parties, notwithstanding a Know Your Customer (KYC) and ethics check. Thus, before executing such action, both parties must sign a separate agreement that specifies in detail the financial responsibilities of each party and how the revenue will be shared. If there are any questions about ethical conduct and how a deal would look on the front page of the Wall Street Journal, the parties will bring up the idea to general counsel and the board. And then to the Trustees if need be. It is always safest to remember that our code of ethics is best protected and to follow our Vision, Goal, and Mission Statements safely as we have dozens of Presidential foundations we mirror and shine a light on. **DISCLAIMER:** the USPSC and VETS operates an electronic platform where speakers, delegates, and business owners, can seek to discuss, encourage, and sometimes raise money from investors in return for securities, and where investors can talk about opportunities to purchase such securities.
