

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into by and between The US Presidential Service Center® (PSC), The Inn of the Patriots™ (TIOTP) which includes The US Presidential Culinary Museum® (PCM) and American Veterans (AMVETS) Post #12 DC.

Purpose: To have a supportive partnership between The PSC and AMVETS Post #12 DC via the missions that both entities run their perspective organizations through to help veterans and the American public in public service and joint ventures socially and financially.

Roles and Responsibilities:

The US Presidential Service Center agrees:

- To help and support the mission of AMVETS Post #12 DC through the promotion of its moral support of veterans on its website.
- To showcase challenge coins that are available from AMVETS Post #12 DC in the different exhibits throughout its museum. It would showcase two (2) coins facing front and back for the challenge coins existing during the Presidential Inaugural year in office.
- To discuss, strategize, and promote future endeavors that AMVETS Post #12 DC develops.
- To financially support AMVETS Post #12 DC via free use of meeting space, free dinners meeting space, open conventions meeting space, and other financial discounting for a myriad of events held on its properties of the US Eastern seaboard.
- To donate financially to AMVETS Post #12 DC.
- To discount meals down to the raw cost for significant events held by AMVETS Post #12 DC on-site and no profit.
- To cater and support some events for AMVETS Post #12 DC at cost and no profit.
- To create a new policy for hotels to follow regarding specialized, above and beyond the handicap laws in America for ADA compliance, parking spots. With substantial publicity, this new standard will pave the way for all lodging laws, housing laws, and ADA parking spots to be enhanced and named "The Sherman Gillums Act."

American Veterans agrees:

- To provide The PSC with non-financial support so that it can continue to provide the community historical insight of what has taken place throughout the country's history as it relates to veterans serving. Especially in the White House Military Office (WHMO).
- Encourage and support veterans desiring to go into business for themselves with the financial backing of the PSC, TIOTP, and PCM.

Reporting Requirements:

Timeframe:



This MOU will commence on December 31, 2019 and will dissolve at the end on an agreed upon determined date.
