

30 million steps and counting

Iraq war veteran walks across U.S. to raise money for military families

GROVER — Trey Yocum looked at the worn bottoms of his Merrell hiking boots. They were the seventh pair of he's worn in the past year. He expected this after walking more than 30 million steps in a journey across the United States.

Yocum is raising money and awareness for military families in need through his Drum Hike. He said his grandfather lost his job during the 1980s and became depressed and committed suicide. Yocum saw a good friend of his, an Iraqwar veteran, on the same path as his grandfather: lost his job, diagnosed with throat cancer, survived a car wreck with his pregnant

girlfriend and sulcidal.

"I contacted charities to help, and I got the thirst to want to help more people," Yocum said. "I figured, Why not walk across America?""

The goal is to raise \$5 million. He's raised around \$183,000.

'LAST COUPLE OF MONTHS'

The hike started in Louisville, Ky., April 17, 2010.

Developing kidney stones in Colorado, a footinfection in Texas and walking through a Louisiana tomado weren't enough to end Yocum's journey.

"The first nine months, we helped 17 families," he said. "With Wish Upon a Hero's support, we helped 17 more families in two months."

So far, money raised has paid mortgages on military families' homes on the verge of foreclosure. Yocum wants to raise enough money for a family in Raleigh who lost everything during the recent tomado outbreak.

His wife, Mareiki, and two dogs follow him. He will walk through Raleigh, Washington, Boston and Ohio next.

With a camouflage hat and matching pants, Yocum quickly strapped on his water backpack. He turned left onto Cleveland Avenue in Grover as he walked toward Shelby.

The journey will end September in Louisville on mile 7,000.

"I'm sad it's down to the last couple of months" he said. "It's an honor to meet these families, parents and wives of fallen soldiers."
