ACCEPTANCE OF MINUTES: <u>Motion</u> to accept the July 15, 2024 Regular Meeting minutes as printed:

BUSINESS FROM THE FLOOR:

<u>White Oak Road Closure (Also see New Business)</u>: Does the 5-year road closure fall within the 14 year total agreement (2019 to 2033) or can the road be closed and reopened in 5 years, even if that reopening occurs after 2033?

OLD BUSINESS:

<u>Kozy Rest Sewage Expansion</u>: Solicitor & engineering firm continue to assist with the project completion. Received updated agreement for review on 8-13-24.

Public Sewer:

- 1. <u>Incomplete connections/inspections (5)</u>: <u>Unchanged</u>: D. Brown #2; <u>K. Schumacher</u>; <u>R&M Holdings '09</u>, <u>LLC</u>; McFeaters; 204 Boyers Rd (to be capped by new owners).
- 2. Delinquencies-Three or more months (12): Updated: None sent to Solicitor for collection after 8/1/2024 invoicing. Eleven (11) properties (8 owners) currently are delinquent by 5 months or more. One (1) is 3-4 months delinquent.
- 3. Property Liens (10): Unchanged: D. Brown (debt/connect); F. Carroll-Gillen (debt); J. Green (debt); S. Heller (debt); V. Kennedy (3 properties) (debt); R/J. McFeaters (connect/debt); G. Mullett (debt); H. Russell (debt). Discuss with Solicitor: Carroll-Gillen & Mullett.
- 4. <u>Notice of Claim</u>: Filed on H. Russell estate. House appears to still be occupied by daughter. Waiting for final tax return to be filed.
- 5. Sheriff Sale (6): Updated: J. Green; S. Heller; R. McFeaters; & 3 V. Kennedy properties. V. Kennedy properties were on hold if he paid as agreed. Missed March & July completely & has been late 5 of 8 months he has made payments. Solicitor to inform his attorney we will be continuing Sheriff sale proceedings for non-compliance with the agreement. J. Green: made payments in June and July. Will cancel proceedings if paid in full in August. S. Heller: Solicitor is proceeding. McFeaters: scheduled for Upset/Judicial sale in fall.
- 6. Auto Pay: 38 of 120 accounts (32%) are set up on auto pay.
- 7. **Delinquency Rate:** Total-13%; Severe-9%.
- 8. Grinder Pumps: Received Tepco invoice for grinder pump repair.
- 9. **Emergency Generator**: Marvin will look for a reset switch before we call to have it looked at.

- 10. <u>Concrete Piers</u>: Marvin will look at cost to replace and provide a quote.
- 11. <u>Sludge Removal</u>: Marvin will call to have this done sometime in the Fall.
- 12. Mershimer-Tooley Agreement: Residents contacted to sign by 8-21-24.
- 13. **EADS GIS:** GIS access will be blacked out for a few weeks. Clients will have to access their data though their own ArcGIS accounts after the migration is complete. This will cost approx. \$700 annually if we choose to do this.

CEO: "For Love of the Lost"/Fish property: Solicitor filed with magistrate. S. Fish came to office requesting information and states he has most of the property cleaned up. Was instructed to call Solicitor for answers to specific questions. Hearing attended on 8-14-24 at 10:10 am at SR Magistrate office. Has made improvements. Will schedule another hearing in 30 days.

EMC/Weather - Emergency Management Coordinator:

<u>Shields Rd. Tree</u>: PUC Complaint has been accepted as satisfied. W. Penn Power is to cut down the tree, the Township is responsible for cleaning it up. After agreement was accepted, W. Penn Power is now claiming property owner does not want tree cut down. Solicitor to follow up on this. Letter to be sent to property owner.

<u>Township Constable</u>: Will invite him to the township meeting. The Election Board will invite him to Election training for Constables.

EMS QRS Agencies: Butler Co. 911 center is requesting that municipalities designate a licensed agency to help respond to medical calls in our area. Harrisville VFC will be the designated QRS agency. They will first need to be licensed before we can designate them.

<u>Solar Panels/Solar Farms</u>: Contact solicitor about creating an ordinance. Info. from PSATS Regional Forum will be shared. Rapidly expanding energy business. Need to address new and future technology as it relates to solar energy, as well. Solar company is making a request to go door to door in Mercer Twp. See below D-T-D discussion.

<u>Holding Tanks in Township</u>: Agreements are rewritten for review by supervisors and solicitor. Also, a letter is written for 125 Greenway Lane property since the resident is a retired, disabled veteran.
