2022 CLEANUP DAY: Cleanup day is scheduled for Saturday, May 21st from 7 am to noon at the OLD TOWNSHIP BUILDING, 152
Boomerang Rd. Enter Boomerang Rd. at the North end and exit at the South end. Acceptable items include stoves, refrigerators and other white goods, furniture, and lawn mowers. Unacceptable Items: Liquids of any kinds, hazardous materials, batteries, nothing over 5 feet in length (except furniture), construction debris (drywall, cement blocks, etc.), dirt, sod, grass, rocks, stones, tires, household garbage. 2022 PAVING PROJECTS: Our paving projects this year will be Ethan Hill Dr. and Shields Rd. from Route #8 to the gas well on the Halterlein property, costing over \$140,000. Also, the driveway and parking lot of the Township building will be paved this summer.

BROWNTOWN RAILROAD BRIDGE: This bridge is to be repaired June/July of this year. The railroad does not believe closing the bridge will be necessary. The last repair was in 1995.

NEW EQUIPMENT: After spending close to \$10,000 in repairs in 2021, we have purchased a new JCB 407 Wheel Loader to be delivered sometime this year at the cost of \$54,584.85.

SEWER NEWS: Of the 124 residents that are part of the systems in Forestville and Harrisville, we currently have seven residents not connected to the sewer system and/or not inspected. Legal action is on-going to handle those properties not connected/inspected. If you would prefer to receive your sewer bills by email instead of USPS to reduce costs, please contact the Township office.

BUILDING RENTAL: The Township Community Room is available to rent for small functions. Any interest, please call the office for more details.

DROP BOX: There is a drop-box located on the front of the building for anyone needing to deliver paperwork, payments, etc. Any Township business can be completed by calling the office and making an appointment at 724-735-2705.

PERSONNEL: Last year we announced the need for a part-time office clerk. In June, we hired Nikki Ciochetto as the part-time clerk. She will be handling the sewer billing as well as additional office responsibilities. Nikki has been a great addition to the Township staff.

Martha Hemmerlin was elected as a Township auditor beginning in 2004. For 18 years she has given her time to auditing the Township books and decided not to seek another term. Thank you, Martha, for your dedication to the Township.
