Attempt failed. 8/27 measured culverts for replacement. Two on Harmony rd, one on Station rd. 8/25 Pete picked up load of cold patch from HeiWay to repair culverts and potholes. 9/1 marked culverts and made 811 call to begin repairs 9/14. 9/3 set up culvert cleaning on Sheilds rd for week of Sept 14, State Pipe will be working in area for SR Twp ,while in area they will clean ours, culvert is on Shields rd east of Harmony rd.
