REGULAR MEETING: Meeting was called to order by Chairman, R. Stuchal at 7:12 pm. Members present: W. Walowen, P. Treese and secretary L. Giesler. Visitors present: Kyle and Carrie from EADS Group and Bob Barnes.

MINUTES REPORT: Motion to accept the January reorganizational and regular meeting minutes as corrected by R. Stuchal. Seconded by W. Walowen. All in favor, motion carried.

BUSINESS FROM THE FLOOR: Bob Barnes presented a subdivision that needed signed and sealed. Supervisors signed the subdivision.

OLD BUSINESS: 537 Plan: Met w/Strange Corp. on a time line but weather is a factor. Called Vance Oaks and he needs letter concerning the three properties which has been mailed. MEETING REPORTS: Pine-Harrisville Authority: Board remained the same. \$12,361 in funds. Resolution tentatively passed that PennDOT wanted to buy property by The Boot Box. Are installing box culverts for grade. Passed resolution for \$2,300 pending the on-site meeting with engineers, etc. Next meeting is in March. **Municipal Code Association:** Reorganized, did budget and approved Still dwindling on the sewage side of funds. Short officers. R. Stuchal is now vice president.
