REGULAR MEETING: Meeting was called to order by Chairman R. Stuchal at 7:03 pm. Members present: P. Treese, W. Walowen and secretary L. Giesler. Visitors present: Kyle & Carrie from EADS and Bob Barnes, and Phil Hay from Phil Hay & Sons.

MINUTES REPORT: Motion to accept the January meeting minutes as printed by R. Stuchal. Seconded by P. Treese. All in favor, motion carried.

BUSINESS FROM THE FLOOR: Bob Barnes – rescinded the subdivision from last month. Phil Hay gave the supervisors a price list for possible needs for the township which he can supply. EADS Group – see Old Business.

OLD BUSINESS: 537 Plan: East extension is complete. Passed tests and inspections. Kyle recommends using Wrapidseal on all projects but we don't need to agree to it. Approx. 60 manholes. Need inside and outside testing for each resident. Need to open another account for CDBG grant plan will need to be worked quickly. **139 Shields Road:** Everything is back in our hands. Township may need to clean up the property ourselves. **GC Materials:** Solicitor suggested we take pictures of all equipment currently on the property.

Costars DGS Contract: Due March 15th – 2 loads of regular.

NEW BUSINESS: Tri-County Clean-up day: Scheduled for May 20th. Looks good to supervisors. Will get extra help. **Flood Plain Map:** Secretary will look into. **State Police Service:** Secretary looked at estimated cost at approximately \$27,000. **Koenig Property:** Mr. Koenig wants to extent neighbor's driveway. Using a trailer for storage currently. However, grandson says he will live in it and tie into the resident's septic. Secretary will send a letter letting them know that should the status of the trailer change they must get appropriate permits. It must have a separate septic system.

OTHER BUSINESS: Talked about culverts: Supervisors will take inventory of driveway culverts and inform residents which will give them time to purchase pipe and let them know we will do it somewhere around July/August. **Mercer Twp. sewer fund:** Need to open a new company with \$9,900 plus whatever needs to be left for balance. Will be called Mercer Township Sewer Fund. Motion that between meetings we sign a check for Grove City Borough for \$9,900 by R. Stuchal. Seconded by W. Walowen. All in favor, motion carried.

MEETING REPORTS: None to report.

ROAD REPORT: Truck went out 7 times. 1/3 cleaned ditches south side of Shields to Route #8 intersection. 1/6 mixed 2 loads of antiskid. 1/9 picked up cutting edge for snow plow. 1/11 removed tree from Forestville road. 1/12 cleaned ditches and manholes on Browntown, Harmony and Prairie St. Ext. 1/13 put new cutting edge on plow. 1/30 mixed 1 load of anti-skid. Blew a hydro line on skidsteer. Delivered to Walsh for repair and back in township same day.

FINANCIAL REPORT: General - \$42,566 State - \$17,652 Cap. Res. - \$16,204

Motion to pay bills and transfer \$12,000 from general savings to general checking by R. Stuchal. Seconded by P. Treese. All in favor, motion carried.

ADJOURNMENT: Motion to adjourn meeting at 9:10 pm by W. Walowen. Seconded by P. Treese. Meeting adjourned.
