

Zor Shriners Annual Meeting was opened in full form by the Divan presenting the Salaam for the Potentate.

Potentate L. Riemenschneider called the meeting to order at 1:00 P. M.

Meeting, January 14, 2012, as printed in the Zephyr. M. Severson PP. moved approval and to dispense with the reading of the minutes and seconded by T. Nelson PP. Motion Carried.

Circuses: J. Thorstad PP. reported



in Program Sales over the 2012 circus. 3 bicycles, 1 Red Lobster gift card and 1 Mallards baseball family pass were given away at each show. A tip of the fez to the following units and clubs: Wranglers, Camel Patrol, Wausauken Indians, Midgets, Clowns, Directors Madison Staff, Mini Cars, Road Runners, Southwestern SC, Mound View SC, Lakeland SC, Indianhead SC, Madison SC, Sahara SC, Wild River SC, Past Potentates, and the Divan. Bicycle helmets for all 18 winners were purchased by the Pipes and Drums. Telemarketing was down 2%, Nobles tickets down 1%, PDQ sales up 10%, Advanced Sales even, Gate Sales up 21% and Program Sales up 15%. We had additional costs this year due to the larger attendance, with the Coliseum on ticket surcharges and sales tax and

71 Nobles were in attendance. Chaplain K. Gant gave the opening prayer. The Color Guard presented the Colors and all present joined in the Pledge of Allegiance to the Flag.

Potentate L. Riemenschneider welcomed all present and stated we will proceed to cover the full agenda.

A Candle Lighting Memorial Service was conducted for those Nobles lost to the Black Camel in the Fourth Quarter of 2012. Recorder J. Stelsel read the names of 19 departed Zor Nobles. Chaplain K. Gant offered a prayer for the departed Nobles.

Potentate L. Riemenschneider asked for a motion for approval of the minutes of the last Annual



the 58th annual Madison Circus held Feb. 17-19, 2012 made a net profit of \$125,000. Total attendance for the six shows was 32,539, largest show Saturday 3 P.M. 7360, smallest show Friday 7:00 P. M., 3944. We had a total of 12 units, clubs and Divan and Past Potentates participate. We averaged 75 Nobles and 22 Ladies per show. There was a 15% increase



\$2,260 for additional security. The Dane County Board grandfathered the use of elephants until 2020. George Carden paid approximate 50% of the legal bill for the elephant matter and Dane County. The La Crosse Circuses on Feb 28 & 29, 2012 by contract with George Carden give us a profit of \$3,500. Summers Circus held on June 12 & 13, 2012 in Eau Claire and June 14, 2012 in Menomonie, Zor received \$7,885. A review of this year's Madison Circuses on Feb. 15 - 17, 2013 was given. J. Thorstad PP. moved the report be accepted and seconded by M. Severson PP. Motion Carried.

Trustees' Report: T. Schmidt, Chairman of the Trustees thanked all of the volunteers for serving in 2012. Projects both internal and external in 2012 were a new men's room due to damage caused by an automobile hitting the building, a new A/C wall and rail to prevent erosion and damage to the A/C units, drainage ditch installed next to circular drive to prevent water damage to the building, professional weed control contracted, dance floor and rail boards resurfaced, and the lobby project is nearly completed. Our financial report indicates compliance with investment policies and we had a positive return for the year. Special thanks to Nobles Soderholm, Krinke and Schmidt for fulfilling their terms on Trustees. T. Schmidt moved the report be accepted and seconded by J. Thorstad PP. Motion Carried.

<u>Membership</u> Report: C. Miller reported for B. Calverley. As of December 31, 2012 we had 1643 members. In the fourth quart of 2012 we had 21 Creations, 1 Restoration, 1 Assoc. dropped, 5 Demits, 14 Deaths, 1 Resignation and 64 Suspended for a change in membership of -63. C. Miller moved the report be accepted and seconded by J. Thorstad PP. Motion Carried.

Treasurer's Annual Financial Report: D. Anderson, Treasurer reported as of December 31, 2012 YTD Total Revenues \$799,655 and Total Expenses \$332,244 for a net gain of \$467,411. D. Anderson moved the report be accepted and seconded by T. Nelson PP. Motion Carried.

R. Winter, **Onion Report:** Onion Chairman, thanked all of the clubs & units for their participation with the onion sales. Zor's net income was \$20,659.76 and each club & unit received \$2.00 for each 10lb bag they sold. Each club & unit is urged to sell onions again this year and each Zor Shriner is encouraged to buy one bag and sell one bag and pre-selling is always good too. Winter stated he will serve as onion chairman in 2013 & 2014 but would like someone to step forward and work with him the next two years and then take over in 2015. R. Winter moved the report be accepted and seconded by J. Soderholm PP. Motion Carried.

Gun Raffle Report: M. Bradley reported for the last three years our raffle has become a bigger success each year. Tickets were sold by some Shriners and by others, although not Shriners. He feels we can do a better job on publicity this year. He thanked the office staff and all the volunteers who helped to insert the stubs into the vials. The totals for the 2012 raffle are, 2500 tickets printed, 2180 sold, \$43,600 Gross Receipts, \$19,188.243 costs and \$24,411.76 Profit. M. Bradley moved the report be accepted and seconded by J. Soderholm PP. Motion Carried.

Twin Cities Hospital Report: R. Rommel, a member of the Twin Cities Hospital Board of Governors reported approved applications through November are 6.1% over last year; 732 compared to 690. House surgical operations totaled

625 which is 35 more than last year. The budget for 2013 is \$28,188 less than the 2012. There is a fullscale recruitment for two full time pediatric orthopedic surgeons. Dr. Cary Mielke is the new interim Chief of Štaff. The hospital successfully introduced new software for managing outpatient records. Both Mayo Clinic and the Joint Boards have voted approval of the proposal to join the Mayo Clinic Network. There were only four uninsured surgeries in November. Insurance cash receipts for November were \$619,918 with a total through November 2012 of just under five million dollars. Thank you to the drivers for their time and the miles they have driven and thanks to all in Zor. R. Rommel moved the report be accepted and seconded by T. Nelson PP. Motion Carried.

Johnson Insurance: Κ. PP. Chairman of the Insurance Committee reported the other members of the committee are J. Olson and L. Myers. Agent Tony Arneson of the Neckerman Insurance Services has reviewed the entire program for the committee. They have done an updated replacement cost analyses of the buildings and updated the values. The Zor office sent each club & unit a copy of their past requested coverage and asks for an updated copy to be returned by October 1 for use in the next year coverage plan. The Zor Trustees updated the personal property of Zor. The Directors and Officer Coverage had been moved to a new carrier for a slight reduction in cost. All coverage's meet or exceed the minimum limits required by Shriners International at this time. One claim when a driver hit our building was somewhat a problem but Progressive Insurance Co., our carrier, did finalize it. The committee recommended obtaining certificates of insurance for rental of

the Zor Shrine Center or the renter use the "TULIP" program available from the Neckerman Agency. It is also imperative the driver information form be completed by those drivers transporting patients. If all driver criteria are met, we also recommend obtaining a quote for a \$5M umbrella to replace our \$2M currently in place. The Divan would then need to consider the need to update our liability limits to offer better protection of Zor resources. Remember Hospital Dads drive safe and clubs & units continue to provide great visibility of Shrine while following the rules and being careful. K. Johnson PP. moved the report be accepted and seconded by T. Nelson PP. Motion Carried.

Variety Shows: S. Peterson PP. reported the second year for Variety/ Magic Shows was a success both for Zor and the clubs & units that sponsored the shows that were put

on in 15 communities throughout Dam, Mascoutin SC - Wautoma, St. Croix SC - River Falls, Vacationland

Zorland. The net profit for the clubs & units was \$13,034.50 and for Zor \$19,760.74 for a grand total of \$32,795.24. This is the second largest fundraiser for Zor Shriners. A special thanks to Heart of Wis. SC - shows in Wis Rapids, Stevens Point and Marshfield, Timber SC show in Medford, Southwestern SC - Platteville, Beloit SC - Beloit, Mini Cars - Janesville, Green County SC - Monroe, Badger SC - Beaver



SC - Baraboo, Hayward Musky SC - Spooner, Vernon County SC - Viroqua, Flambeau Clowns -Phillips. Most of the shows were between June 5 & 21. This year the shows will start at 6:30 P. M. instead of 7:30 P. M. We are looking at 3 additional communities this year.

A special thanks to the clowns from the Funsters, Jesters, and Flambeau who came in costume to entertain the kids. Thanks to the Nobles & Ladies that distributed tickets and attended the shows. S. Peterson PP. moved the report be accepted and seconded by J. Thorstad PP. Motion Carried.

Budget Request for 2013: B. Gorsuch moved approval of the proposed 2013 budget and

seconded by M. Severson PP. Motion Carried.

Approval by the membership of the 2013 Auditor: B. Gorsuch moved SVA be approved as Auditor



and seconded by T. Nelson PP. Motion Carried.

Approval of the 2013 Summer Circuses, La Crosse, Eau Claire and Menominee. Football Games at La Crosse, River Falls and Whitewater, Variety/Magic Shows and Gun Raffle. B. Gorsuch moved for approval and seconded by M. Severson PP. Motion Carried.

Approval of 2014 Potentate's Trip: L. Hanson asked for approval to plan and take a Potentate's Trip maybe to Branson or Nashville in 2014. T. Nelson PP. moved for approval of the trip and seconded by S. Peterson PP. Motion Carried.

Potentates Report: Riemenschneider thanked the Divan, his appointments, Clubs & Units, all the Nobles and office staff who helped him have a great and successful year.

Appointment of Tellers: L Riemenschneider appointed T. Nelson PP., J. Thompson PP. and N. Allen PP. to serve as tellers, if needed for the election of officers and/or trustees.

Nominations for the Election Potentate Officers: L. Zor Riemenschneider declared Shriners was in order for the election of officers for the year 2013.

Potentate: The name of B. Gorsuch was placed in nomination by J. Soderholm PP. and seconded by R. Winter. There being no other nominations E. Buehler PP. via telephone, moved the rules be suspended and the Recorder cast a unanimous ballot for B. Gorsuch for Potentate and seconded by T. Nelson PP. Motion Carried.

Chief Rabban: The name of L. Hanson was placed in nomination by T. Nelson PP. and seconded by J. Thorstad PP. There being on other nominations M. Severson PP. moved the rules be suspended and the Recorder cast a unanimous ballot for L. Hanson for Chief Rabban and seconded by J. Thorstad PP. Motion Carried.

Assistant Rabban: The name of M. Steiber was placed in nomination by S. Willett PP. and seconded by J. Thorstad PP. There being no other nominations M. Severson moved the rules be suspended and the Recorder cast a unanimous ballot for M. Steiber for Assistant Rabban and seconded by T. Nelson PP. Motion Carried.

High Priest and Prophet: The name of B. Geisler was placed in nomination by S. Peterson PP. and seconded by S. Willett PP. There being no other nominations K. Johnson PP. moved the rules be suspended and the Recorder cast a unanimous ballot for B. Geisler for High Priest and Prophet and seconded by J. Thorstad PP. Motion Carried.

In these final weeks, everyone should be in the circus mode. We can always use a few extra set of hands. Please volunteer in helping to deliver the school tickets on Feb. 4th and 5th.

Potentate Bob Gorsuch reminds everyone the importance of paying for your sheet of tickets, with a \$ 96 face value, you only pay \$ 70 and get added to the Ringmaster's Club, which is printed in the April Zephyr. Zor's welfare relies on the financial outcome of this major fundraiser, it also is our biggest public relations event. The Potentate also reminds to turn in only one parking stub per

day. \$ 6 per stub may not seem to be a lot, but the approximate \$ 900 could be Zor profit.




